**Narrative:**

On Monday, August 4, 2025, at approximately 1700 hours, SA Kenneth Smith met with Dakota Schneider and Chris McNeely at the Trenton Police Department, located at 11 E. State Street in Trenton, Ohio. The purpose was to return property related to this case, including jewelry, specifically rings, which were entered into BCI Evidence from the post-mortem examination (autopsy) of Consuelo Denise Kerr and Ronald Kerr.

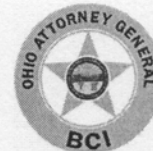




