Narrative:

On Wednesday, January 28, 2026, the investigation regarding the officer-involved critical incident that occurred in Ashtabula County, Ohio, on September 8, 2025, was ruled on by the Ashtabula County Prosecutor's Office. The Ashtabula County Prosecutor's Office declined to file criminal charges regarding the actions of the involved officers in relation to the death of Jerry Pegram.

In the letter sent by Ashtabula County Prosecutor April Grabman she noted:

Upon receiving the file, an independent review was completed. It is the opinion of the Ashtabula County Prosecutor's Office that it is not necessary to present this case to the Grand Jury for potential charges. From the evidence presented, it is clear that law enforcement officers were legally justified in the use of deadly force that led to Mr. Pegram's death on September 8, 2025.

All evidence in this case has been returned to the requesting agencies. Special Agent Lamping and Special Agent Supervisor Moran reviewed this investigation and discussed the documentation. During this discussion, it was determined that the investigation was sufficiently pursued and all investigative efforts and aspects of this case have been completed. Special agent assistance is no longer required by the requesting agency.

RE: Jerry Pegram Incident on September 8, 2025

To Whom it May Concern:

The Ashtabula County Prosecutor's Office has finished reviewing the matter involving the shooting death of Jerry Pegram.

On September 8, 2025, at 2:41 P.M. a deputy from the Ashtabula County Sheriff's Office (hereinafter "ACSO") attempted to make a traffic stop of a red motorcycle being operated by an unknown subject, later identified as Jerry Pegram (hereinafter "Pegram"). Pegram failed to comply with the visible and audible commands coming from the marked Sheriff's vehicle. The driver of the motorcycle was observed repeatedly throwing "packages" and/or "baggies" off the rear of the motorcycle. The motorcycle was also observed swerving in and out of the southbound and northbound lanes of travel, creating a safety risk for himself and other vehicles on the roadway. As the pursuit continued, three additional deputies from ACSO joined the pursuit. Further, one Ohio State Patrol Trooper was nearby to assist.

The pursuit continued until approximately 3:05 P.M., a total of 22 minutes. It ended when Pegram wrecked the motorcycle and took off on foot. Pegram was unable to be identified during the pursuit because he was wearing a mask throughout the vehicle and foot pursuit.

Following the crash, Pegram fled into a wooded and tall grass area. Law enforcement officers continued to pursue Pegram on foot off the roadway. One of the officers released his K9 partner, and the K9 was the first to engage Pegram.

Officers approached Pegram and observed he was concealing his hands under his body and then moved his hands to his pocket in an attempt to retrieve something. One officer attempted to subdue Pegram using physical force, however he continued to roll around and not comply to repeated commands of "let me see your hands" and "take your hands out of your pocket." A taser was also deployed in an attempt to subdue Pegram with nonlethal force, however this was also unsuccessful.


Law enforcement then observed the suspect roll to his back and point a firearm directly at them. Officers continued to give verbal commands to deescalate the active threat Pegram posed to their lives. One officer yelled "Gun, gun, gun!", "Do not do it! Do not do it!", "No, No!" Pegram did not lower his weapon and continued to point it directly at law enforcement causing an active and ongoing threat to their lives.

Officers then used deadly force in order to neutralize the active threat, which ultimately resulted in Mr. Pegram's death. Following the neutralizing shots, law enforcement immediately removed and secured the firearm from Pegram's person and began life saving measures.


Ashtabula County Sheriff, William R. Niemi, contacted the Ohio Bureau of Criminal Investigation (BCI). BCI responded to the scene, and a thorough and independent investigation was completed. Once BCI completed its investigation, BCI forwarded everything to the Ashtabula County Prosecutor's Office for review.

Upon receiving the file, an independent review was completed. It is the opinion of the Ashtabula County Prosecutor's Office that it is not necessary to present this case to the Grand Jury for potential charges.
