Narrative:

On November 4, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) completed a review of the video captured from the body-worn camera (BWC) of Officer Michael Dugan (Officer Dugan) during this incident.

Amped Replay was used to review the videos.

SA Valente made working copies of the seven BWC videos and placed the copied video in a folder on his BCI issued laptop. The working copies of the videos were used for the review.

Officer Dugan walked across a neighboring yard and approached the subject's home from the rear. As Officer Dugan reached the rear open garage of the subject's home, Officers Perez and Franklin were visible standing at the northeast corner of the garage.

After Officer Dugan made the above noted statement, a sound consistent with the man door leading from the garage into the home being opened was heard. A male voice seeming to come from inside the home stated "Whoa, whoa, whoa" immediately after the door was seemingly opened. Officer Dugan yelled out, "Hey, come out with your hands, come out with your hands up." Officer Dugan next stated, "He went back inside when he saw officers." Officer Dugan then continued to provide watch on the corner of the garage. From that position, Officer Dugan yelled into the home, "Christian, can you come out with your hands up?"

Around the 5,060th frame or 5:37 mark of the recording, a voice coming from inside the home, believed to be the subject's, could be heard saying, "I can't do this! I can't do this!" A second voice believed to be the subject's father interrupted, and the two were heard briefly arguing, with the second voice saying "Don't shoot me. You want to shoot me? You want to shoot your daddy?" The argument between the two men continued inside but was generally too muffled to discern specifically what was being said.

The group of three officers appeared to be unaware of where the subject was located. Officer Dugan took the lead position on the northeast corner of the garage closest to where the subject was located. After briefly pausing at the corner of the garage, Officer Dugan moved forward to a position on the northeast corner of the home at the three-seasons room.

In the following moments, Officers Dugan, Perez, and Franklin quickly worked their way around the subject property from the south side yard to the front yard and neighboring front yard, where they were met by other officers and the subject's family.



Woda, who lived in the home directly north of the subject's residence, where the subject expired, told the detective she did not see the shooting occur. Woda did report hearing yelling outside the home. Woda stated at the 1:07:29 mark of the recording she heard, "What, I think one or two shots that maybe might have been his then, and then we heard probably your shots." Officer Dugan then provided Woda with a written statement form and requested that she fill out the form with what she heard and what her daughter told her. shouting outside. Woda reported it was not unusual to hear loud voices coming from the neighbor's home, so she did not pay special attention to what was happening. Woda then heard one or two pops, that she then thought were gunshots fired by the subject. Woda stated she knew the subject had a gun in the past. The detective asked Woda if she knew the difference in the sound of a rifle and pistol firing. Woda stated she did not. Woda did say the first two apparent gunshots she heard were distinct from the following gunshots she heard. Woda described hearing, "pop, pop, and then the burst." When asked if she heard anything that sounded like a gunshot earlier in the night, prior to police arrival, Woda originally said no then said yes. Woda described thinking at the time she heard a grill fall over or something like that rather than a gunshot.

Woda, who was upstairs at the time of the officer-involved shooting yelled for her daughter on the first floor to come upstairs after hearing the group of gunshots. Her daughter yelled back that she couldn't as she was lying on the floor.

Woda then reviewed and added information to the witness statement form completed by Officer Dugan at her request. Woda told Officer Dugan she did not believe she would allow her daughter to be interviewed by police and Woda herself would talk to her daughter and let police know if she saw anything related to the shooting.

Beginning around the 10:43 mark of the recording, Genisis Thomas (Genisis) and another unknown woman who appeared to be the subject's mother arrived on scene and stood at the crime scene tape line. Genisis requested to retrieve car keys from inside the home.
