NARRATIVE

MENACING

On Saturday, August 26, 2023, while assigned to Z/C 4B21 with PO Moyano #2085, we received a priority 1 radio assignment for someone threatening with a weapon at 7826 Spafford Road. Before we arrived on scene, radio informed us that the male stated that it was a toy gun shooting plastic orange balls.

When we arrived on scene, we met [REDACTED] (V) who stated that the white male (later identified as Robert Perkins (NS)), pointed a toy gun at him when he was driving. [REDACTED] stated that he was parked at the stop sign at Spafford Road and Canton Avenue. While he wasn't looking, Perkins snuck up on him and began pointing the toy gun at [REDACTED] head. [REDACTED] was caught off guard and was scared because he believed that Perkins was pointing a real gun at him. [REDACTED] then heard Perkins laugh and turned to see that he Perkins was holding a "nerf gun". He shot a nerf dart at rivers and then walked back into his house. [REDACTED] then went home and called the police. He stated that Perkins had gone into the house at 7702 Spafford Road. We then went to this address and spoke to Perkins. Perkins stated that he did it as a joke and that everyone had been laughing at it.
