Narrative:

On May 24, 2022, at 1036 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent Steven Seitzman (SA Seitzman) interviewed Kyle Hollins (Mr. Hollins) regarding information he had as a witness to the Officer-Involved Critical Incident that occurred on May 20, 2022, involving the Miami Township Police Department (MTPD). On May 20, 2022, MTPD Sergeant Josh Bail informed SA Seitzman that Mr. Hollins witnessed a portion of the Officer-Involved Critical Incident and provided a written statement to MTPD. SA Seitzman was further informed that Mr. Hollins is an employee of Harky's Motorsports, which is located on the north side of SR-28 Business across the street from the Berry Lane Apartments. The parking lot of the Berry Lane Apartments was the location of the Officer-Involved Critical Incident.

The interview was recorded on a handheld digital recording device. The details below summarize the pertinent portions of the recorded interview and are not a verbatim account. Further, this report was placed in a chronology to aid the reader's overall understanding of the information elicited during the interview and may not be reflective of the actual sequencing of questions. It is suggested that the full audio recording be reviewed to clarify the content of the interview.

Mr. Hollins advised SA Seitzman of the following information:

Mr. Hollins was working in the garage of Harky's Motorsports when he heard three random "pops," which he initially assumed were fireworks. He estimated police officers arrived approximately ten or fifteen minutes after the first shot. He observed three police cruisers arrive. He said he could see "red and blue lights," then heard a third shot. He then heard officers yelling; However, he was unable to hear what they were saying. He saw the officers take cover behind their car doors and police cruisers. He and another employee, William 'Jake' Harkleroad, ran inside the business to take cover. He said he heard approximately ten shots as he was

running inside. He was uncertain whether the shots were coming from a single source. He advised he "just heard gunfire."

Mr. Hollins confirmed that he only heard the shots and never observed anyone shooting.

The interview was concluded at 1042 hours. The audio recording is attached below. Also attached is the written statement Mr. Hollins provided to MTPD.


