Narrative:

On October 6, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) and SA Jesse Bynum (Bynum) conducted a neighborhood canvass around 10242 Silvercreek Road, Doylestown, Ohio. The purpose of the canvass was to identify and interview potential witnesses to the officer involved shooting that occurred near the intersection of Silvercreek Road and Madison Trail in Wadsworth, Ohio, on October 5, 2024. During the neighborhood canvass, SA Bynum made or attempted contact with the residents at the following addresses:

10340 Silvercreek Road, Wadsworth, Ohio:

At approximately 0023 hours, contact was attempted with no success. A business card and door hanger were left to request contact. On October 6, 2024, at approximately 1024 hours, Sara Keller (Keller) from 10340 Silvercreek Road called SA Bynum and stated that she was home during the incident and heard approximately six to ten gunshots. Ritter further explained that she did not see the incident and only observed the cars on Silvercreek after the shooting had occurred. Keller stated that an officer came to her door and checked on them to make sure they were ok. There were no cameras on the residence that would face the area of the incident. A portion of this interview was recorded and attached to this report.

10366 Silvercreek Road, Wadsworth, Ohio:

On October 6, 2024, at approximately 0027 hours, Special Agent John Tingley and SA Jesse Bynum contacted Anthony Sumey (Sumey) at 10366 Silvercreek Road. Sumey stated that he was in the house during the incident and heard approximately six to nine gunshots that he initially thought were fireworks. Sumey further explained that he did not see the incident and only observed the cars on Silvercreek Road after the

442 Madison Trail, Wadsworth, Ohio:

On October 6, 2024, at approximately 0043 hours, contact was attempted with no success. A business card and door hanger were left to request contact. On October 6, 2024, at approximately 0958 hours, Mark Onofrietti (Onofrietti) from 442 Madison Trail called SA Bynum and stated that he was home during the incident and heard an unknown number of gunshots that he thought were fireworks. Onofrietti further explained that he did not see the incident and only observed the cars on Silvercreek after the shooting had occurred. There were no cameras on the residence that would face the area of the incident.

445 Madison Trail, Wadsworth, Ohio:

On October 6, 2024, at approximately 0049 hours, contact was attempted with no success. A business card and door hanger were left to request contact. On October 7, 2024, Jeff Gonser (Gonser) from 445 Madison Trail called SA Bynum and stated that nobody was home during the incident and the doorbell camera that faces Silvercreek Road did not record due to the distance away.

465 Madison Trail, Wadsworth, Ohio:

On October 6, 2024, at approximately 0056 hours, contact was attempted with no success. A business card and door hanger were left to request contact. It did not appear that there were cameras on the residence that would face the area of the incident.

472 Madison Trail, Wadsworth, Ohio:

On October 6, 2024, at approximately 0100 hours, contact was attempted with no success. A business card and door hanger were left to request contact. On October 7, 2024, Matt Ritter (Ritter) from 472 Madison Trail called SA Bynum and stated that he was home during the incident and heard approximately six to seven gunshots. Ritter further explained that he did not see the incident and only observed the cars on Silvercreek after the shooting had occurred. There were no cameras on the residence that would face the area of the incident. A portion of this interview was recorded and attached to this report.

500 Madison Trail, Wadsworth, Ohio:

On October 6, 2024, at approximately 0106 hours, contact was made with the residents at 500 Madison Trail. Veronica Pavkov (Pavkov) stated that she heard a noise
