#### Narrative:

On Friday, June 06, 2025, the Knox County Sheriff's Office (KCSO) requested the Bureau of Criminal Investigation (BCI) assistance at the scene of an officer-involved critical incident at 10180 Bussenburg Rd., Howard, Ohio. As part of that investigation, Special Agent (SA) Aja Chung (SA Chung) was requested to attend the post-mortem examinations of two decedents, Lauretta Beltz-Frazee (Beltz-Frazee) and Lloyd Ray (Ray). The examinations were conducted on June 6, 2025 at the Licking County Coroner's Office in Newark, Ohio. The post-mortem examinations were conducted by Dr. Jeffrey Lee.

Dr. Jeffrey Lee advised the following during the autopsy of Beltz-Frazee. Ms. Beltz-

During Ray's autopsy, Dr. Lee observed

There was no projectile recovered.

SA Chung requested to receive a copy of the full autopsy and toxicology reports for both Beltz-Frazee and Ray once available.

As a result of the autopsy, the following items of evidence were collected and transferred to the custody of SA Chung:

- 1. Clothing from Beltz-Frazee (submitted to the major crimes evidence vault)
- 2. Projectile recovered from Beltz-Frazee's body (submitted to the BCI FA laboratory)
- 3. Beltz-Frazee DNA blood card (submitted to the major crimes evidence vault)
