**Narrative:**

On the morning of September 10, 2024 at approximately 0130 hours, Lamine Mahmoudi was mortally wounded during an Officer-Involved Critical Incident with members of the Columbus Division of Police. The incident occurred in the rear parking lot of the Columbus Police Precinct 4 Substation. Lamine Mahmoudi's autopsy was performed later on 9/10/2024 at 0900 hours, by Dr. Jeffrey Nine, Deputy Coroner, of the Franklin County Coroner's Office. The forensic toxicology report for Mr. Mahmoudi was completed on 9/23/2024. Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) James Gore reviewed both reports, and a summary is as follows:
