Narrative:

On April 18, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent Doug Eveslage received the Hamilton County Communication Center radio traffic for multiple dispatches to the area of 4411 Montgomery Road reference an animal complaint, erratic behavior, and psychiatric emergency.

On April 25, 2025, SA Doug Eveslage reviewed the radio traffic and noted the following:

- Female driver of red van with multiple dogs acting "super erratic."
- Animal complaint for homeless male with animals unattended.
- SPCA unit requested by Norwood Police to help with multiple animals.
- Psychiatric Emergency at 4411 Montgomery Road, male subject with no shirt or shoes on walking around the garage.
- Life squad staging at 4411 Montgomery Road to assist.
- Mobile Crisis Team advises 38 minutes away from incident location.
- MCT updates they are 18 minutes away from incident location
- Norwood requests more units and advises fighting with one; all county broadcast goes out.
- HCCC cancels all county broadcast, enough units on scene.
- Norwood Police takes female to the medics.
- Norwood Lieutenant enroute to the hospital.
- MCT unit on scene.
- Norwood Police advise riding in the back of the life squad to UC hospital main and units are 12 minutes away.

It should be noted that the audio recording is 54:30 minutes long with faster audio and does not have time in between radio traffic; therefore, the actual timing of events may not match

the duration elapsed during the incident. For reference, the MCT unit advised 38 minutes away; however, approximately 14 minutes of time elapsed prior to MCT unit's arrival.
