Search Warrant Obtained

Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman drafted a search warrant for Taylor Coleman Anthony Cotton's Premier Health Miami Valley Hospital medical records. On Monday, November 18, 2024, SA Seitzman submitted the search warrant to Montgomery County Common Pleas Court Judge E. Gerald Parker, Jr. electronically via the Ohio Community Supervision System. On the same date, at approximately 1355 hours, Judge Parker authorized the search warrant.

Search Warrant Executed

On the same date, at approximately 1402 hours, SA Seitzman submitted the search warrant to the Miami Valley Hospital electronically at mvrroi@premierhealth.com.

On November 27, 2024, at 1344 hours, the Miami Valley Hospital sent responsive records via email to SA Seitzman.

On Thursday, January 23, 2025, the search warrant and inventory were returned to the Montgomery County Common Pleas Clerk of Courts.





AFFIDAVIT (For Search Warrant)

MONTHE MATTER OF SEARCH OF: Miami Valley Hospital Records of Taylor Coleman Anthony Cotton (DOB: 06/26/1998)

STATE OF OHIO, MONTGOMERY COUNTY, SS:

Before me, the undersigned Judge, personally appeared **BCI Special Agent Steven Seitzman** (affiant), who being first duly cautioned and sworn on oath, deposes and says:

- I. That in the CITY of **Dayton**, Montgomery County, Ohio, the criminal offense(s) as listed in Paragraph "I" of the Search Warrant in this matter have occurred.
- II. That Affiant requests the issuance of a Search Warrant for the items of property listed in Paragraph "II" of the Search Warrant in this matter.
- III. That the said items of property are concealed upon the person(s) described and/or the place(s) described in Paragraph "III" of the Search Warrant in this matter.
- IV. That the facts upon which the Affiant bases said beliefs are:
 - 1. Affiant is a Special Agent with the Ohio Bureau of Criminal Investigation and has been a State of Ohio Peace Officer for over 16 years. Since January 2022, the affiant has been with the Ohio Bureau of Criminal Investigation in the Special Investigation Unit, which investigates officer-involved critical incidents, homicides, and other investigations. For over 11 years, the affiant was employed by the West Chester Township Police Department in Butler County, Ohio, and while so employed, he investigated violent crimes and property crimes, including, but not limited to vehicular homicides, robberies, burglaries, felonious assaults, and other violent and non-violent crimes. The affiant has been involved in numerous vehicular homicide and violent crime investigations that led to arrests and convictions. Furthermore, the affiant has investigated dozens of officer-involved critical incidents.
 - 2. On Saturday, October 19, 2024, at approximately 0819 hours, the Montgomery County Regional Dispatch Center received a call from Pamela Osborne. Ms. Osborne was reportedly uncooperative with police dispatchers. She told dispatchers in her initial call that someone she knew, later identified as Taylor Coleman Anthony Cotton, threatened to kill her. She also reported that two days prior to her call, Cotton threw bricks in the roadway and set a house on fire. She provided an address of 1273 Rosedale Drive, which is located in the city of Dayton, Montgomery County, Ohio.
 - 3. In a second call made on the same date at approximately 0827 hours, Ms. Osborne mentioned a person with a gun. A male subject in the background, who, based on information obtained through the investigation, is believed to be Taylor Cotton, said he was going to have a shootout with the police.
 - 4. Several Dayton police officers responded. The first officers arrived at approximately 0836 hours. Unbeknownst to the officers, Cotton had left the area in a tan Buick sedan prior to their arrival.
 - 5. At approximately 0842 hours, Cotton returned in the tan sedan. He drove south on Rosedale Drive and turned right onto westbound Access Road. He stopped just west of the intersection. Once the vehicle stopped, Cotton opened the driver's door and was observed by officers holding a long gun with the barrel pointed straight up.
 - For approximately twenty-seven minutes, officers made several attempts to convince Cotton to drop the weapon to end the situation without incident.
 - 7. Cotton ultimately exited his vehicle at approximately 0909 hours. As he exited, he reportedly pointed the long gun in the direction of several police officers positioned on Rosedale Drive beside a parked vehicle. Eight police officers discharged their weapons, striking Cotton multiple times.
 - 8. Officers provided medical aid to Cotton. Eventually Dayton medics arrived and took over patient care.
 - 9. The Dayton medics transported Cotton to Miami Valley Hospital in Dayton, Montgomery County, Ohio, where he ultimately succumbed to his injuries.
 - 10. Affiant knows through experience that medical staff at the Miami Valley Hospital routinely prepare reports, document observations, and record information from instruments used for evaluating patients under their care.
 - 11. Based on the aforementioned information, the affiant believes that the Miami Valley Hospital is in possession of records related to the medical care of Cotton initiated on October 19, 2024, which will contain information of evidentiary value relevant to the investigation being conducted by BCI. Specifically, the affiant believes that the medical records will provide information describing the cause, type, and extent of the injuries sustained by Cotton, the types of medical interventions attempted, and other circumstances related to the incident under
