Narrative:

On Monday, November 17, 2025, the Ohio Bureau of Criminal Investigation (BCI) was requested by the Union Township Police Department (Clermont County) to investigate an Officer Involved Critical Incident that occurred near 4272 Cider Mill Drive, Union Township, Ohio, resulting in the death of Thomas Noble (Noble).

Investigators learned that Noble had been transported to the hospital by the Union Township Fire Department. On November 17, 2025, at approximately 2335 hours, Ohio BCI Special Agent Sean Zint (SA Zint) responded to Anderson Mercy Hospital, located at 7500 State Road. SA Zint met with Union Township Police Detective (Det.) Bryan Taylor near the Emergency Room Department. Thomas Noble was located in Emergency Room 1. Det. Taylor stated that Thomas Noble was pronounced deceased at 2213 hours by Dr. Devin Patchell.

At approximately 2350 hours, Hamilton County Coroners Investigator Lance Smith arrived at Anderson Mercy Hospital. The body of Thomas Noble was photographed and transported to Hamilton County Coroner's Office, located at 4477 Carver Woods Drive, Blue Ash, Ohio 45242. SA Zint took several photographs of Noble prior to being transported.

SA Zint obtained a sealed brown paper bag containing Noble's clothing removed by medical staff. The evidence was collected by Rhae Patel, from Anderson Mercy Hospital. An evidence transfer receipt was completed by SA Zint and the evidence was transported from the hospital to the scene, where it was transferred from SA Zint to BCI Crime Scene Technician Holly Ryczek.


