**Narrative:**

On May 17, 2024, Ohio Bureau of Criminal Investigation (BCI) Administrative Professional Betsy Farris submitted items to the BCI Laboratory for an analysis.

The analysis requested was to obtain and identify DNA present on the subject firearm and to identify source firearms for the recovered cartridge casings and projectiles. Operability testing was also requested for each submitted firearm.
