**Narrative:**

On Wednesday, March 09, 2022, at 1137 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matt Collins (SA Collins) conducted a phone interview with Sheena Doumbouya (Doumbouya), relative to the Officer-Involved Critical Incident which took place on Monday, March 7, 2022. The interview took place over the phone. The purpose of the interview was due to Doumbouya indicating she had additional information. SA Collins had called Doumbouya around 1100 hours in order to see if she still wished to speak with a victim's advocate. It was during that brief conversation, Doumbouya indicated she had additional information related to the assault. She was further stating she was being harassed or threatened by Rayshawn Meeks' brother, Carl Meeks. SA Collins called back after being able to record the conversation.

Doumbouya was stating she believed there was a knife involved in the incident where she was assaulted by Rayshawn Meeks. Doumbouya stated when she got home she realized there was a kitchen knife in the back seat of her car and she believed the knife is what caused the injury to her face (cut) and injury to her hand (cut). SA Collins mentioned she'd stated she cut her hand from falling. Doumbouya stated she had an opportunity to think about things more and realized she did not fall to the ground and she confirmed that from watching the video that was now on the news. Doumbouya continued by stating, Rayshawn Meeks was the only individual she'd had riding in her back seat and the knife belonged in her house. Doumbouya was asked specifically if she recalled the knife being involved in the incident or if she was only indicating the knife was involved, based on finding in the car where Rayshawn Meeks was sitting.

Doumbouya was asked if she still wished to speak with a victim's advocate and she stated yes. SA Collins asked her if it was okay for him to provide her phone number to the advocate and she stated yes.

Doumbouya had mentioned Carl Meeks and family harassing her on Facebook. SA Collins explained to Doumbouya if she felt threatened or in danger, she should contact either the Sheriff's Office or Columbus Police Department.
