#### Narrative:

As part of this investigation, radio traffic from the incident, as well as other dispatch-related material, was requested from the Akron Police Department. Mobile Data Terminal entries and instant messages from cruiser to cruiser related to this incident were also requested.

Special Agent (SA) Cory Momchilov (Momchilov) was later provided two audio files from the Akron Police Department:

- WilbethOIS Dispatch
- WilbethOIS PatTac1

Both files are continuous audio recordings.

**WilbethOIS Dispatch** contains the audio radio traffic from the attempted traffic stop, pursuit and officer-involved shooting. SA Momchilov listened to and transcribed the dispatch audio.

#### WilbethOIS Dispatch

Car has a 39 Tallmadge and Thayer.

Car he's not stopping signal 5, Henry-Ocean-Nora-45-14, continuing eastbound on Tallmadge, speeds are 43.

**Unknown:** is this a chase? If so, get your sirens on please.

**Car** affirm make it a chase.

Car we're east on Tallmadge approaching RT 8 South, signaling to go 8 South, speeds are at 30, getting on to 8 South from Tallmadge, reason for stop was traffic and equipment violation.

**Car 46:** 46 copies.

**Dispatch:** All cars standby, chase procedure is in effect.

**Car** 21 shots fired, that vehicle just had a shot come out of its door.



Car We're southbound on Route 8 now, next cross is going to be Perkins, going across the blue bridge on Route 8 South, speeds are 80, middle lane, silver Buick, one occupant, looked like a black male driver.

Car He's in the left lane we're going 60. we're ok, for the notes, the driver appeared to have been grabbing something and the shot came out through his door. We're 8 South, just passing Perkins, 8 south passing Perkins, middle lane, speeds are 72, light traffic. 8 south passing exit 1A, speeds 77, no traffic at this point.

Car Car I'm secondary.

Dispatch: Copy.

Car We're 8 south toward 77 south passing exit 0 just passed the University. Middle lane, speeds are 70, now it's in right lane, speeds are 70, light traffic, vehicles are getting over. Continuing 8 south, speeds are 78, light traffic, vehicle is about 100 yards in front of us, continuing 77 south just passed the interchange.

**Car** Car requesting to join, I have three units in front of me.

Car 46: 4-6 to Car go ahead.

**Car 46:** Everybody else, start blocking intersections in case they get off. Get yourself in good position.

Car Yeah, units up there that are coming up on Lovers Lane, he's coming up on your left side just now, take caution, he was grabbing for a gun, and he did fire a shot out the side of the door.

**Car** Alright we got one, we got 2 units in front of us.

Car we're primary right behind you now, we're continuing on Route 8 south, speeds are, oh he's getting off here. We're gonna be getting off at the Archwood exit. Speeds are 65 miles per hour.

Car Approaching the red light at Archwood, he's gonna be going through the red light continuing southbound approaching North Firestone. Speeds are 35 miles per hour. Running the stop sign, he's going be going westbound on North Firestone Boulevard from here.

Car He's going to be going southbound on Neptune, speeds are 30 miles per hour, there's no traffic on this road. Running the stop sign at Reed, -inaudible- going westbound on Reed from here.

Car Still westbound on Wilbeth, we're passing Evergreen, we're heading towards Main. Looks like we have some units up ahead at the intersection of Main.

Car He's slowing down here, slowing down.

Car 602: 602, I'm right here guys.

Unknown: Update.

Unknown: Shots fired; shots fired.

Unknown: Get a 32.

**Unknown:** Everybody okay up there?

Unknown:-Inaudible-...standby.

Car we got shots fired by the police we're all okay, get a med unit rolling, we got the suspect down.

**Unknown:** Someone grab a medical bag, start EMS.

**Car** gonna need a med unit over here.

Unknown: Close off the streets east and west to this lot.

**Car 11:** 11, 11 we need a 32 on Wilbeth and Clairmont in the parking lot across. Wilbeth and Clairmont.




