Narrative:

On Tuesday, March 22, 2022, Special Agent Supervisor Kevin Barbeau made telephone contact with Delaware County Sheriff's Office (DCSO) Captain Kevin Savage. SAS Barbeau requested an initial report, if available, where DCSO responded to an "active shooter" situation that occurred on the roadway in the area of Interstate 71 north of Gemini Parkway, Delaware County, Lewis Center, Ohio 43035. During said event there was an exchange of gunfire between Columbus Division of Police and an involved individual. Once the individual was taken into custody, the individual was transported to Grant hospital with alleged gunshot wound(s) to the lower body.

SAS Barbeau requested and received the attached DCSO report completed by K9 Deputy Troy Gibson. This report was accompanied by DCSO CAD report, see attached.

SAS Barbeau also requested and received the attached letter of request from DCSO. It should be noted BCI is handling the Officer-Involved Critical Incident, while Ohio State Highway Patrol handle any remaining charges and investigative matters.

8:25:03 AM	On March 11, 2022 Deputies were notified of a black male running down Interstate 71 shooting at passing vehicles. Dispatch advised the suspect was described as a black male with shoulder length braided hair wearing a black jogging suit. I responded from a call I was handling on Orange Road. I proceeded to the area and entered onto 71 Northbound from Gemini Place. As I was entering onto Interstate 71, we were informed Columbus police had one suspect at gun point laying prone on the ground. As I arrived on scene I could see multiple officers from what it appeared, providing aid to a black male. I walked up and	Richardson,Bryce	SO126	SO2

was informed they had shot the suspect and other officers had a second female suspect detained. A female Columbus Officer was holding pressure on his left hip, while multiple other Columbus Officer's and a State Patrol Officer were assisting. I asked the officer's if they had advised medics to come in and they stated no. I then radioed the scene was safe and to have medics enter to treat the suspect. Medic 362 arrived on scene and treated the suspect for his injuries. They loaded him into their medic and a Columbus officer rode with them to Grant Hospital. At this point a Columbus Sergeant asked if I would stand guard over the pistol. I stood by until BCI agents arrived and asked for all officer's to clear the scene. At this point I exited the scene and had no further involvement in the case.

NARRATIVE

On March 11, 2022 members of the Delaware County Sheriff's Office responded to the report of an active shooter on Interstate 71 North of the Gemini exit, number 121. While responding to the scene it was learned that the suspect had been shot by the Columbus Police Department.

Upon arriving on scene there was a large police presence consisting of the Columbus Police Department, Ohio State Highway Patrol, Delaware County Sheriff's Office and possibly other agencies. The scene was located in the north bound lanes of I71.

Upon consultation with Captain Savage of the Delaware County Sheriff's Office. It was determined that Ohio BCI would be investigating the officer involved shooting and the Ohio State Highway Patrol would be investigating the criminal conduct of the suspect, Jonathan Myers.

It was later requested that our office assist the Ohio State Highway Patrol with typing criminal charges on Myers and also a search warrant for the Ford Fusion that Myers was a passenger in.

Trooper Michael Keeton and Trooper Applegate with the Ohio State Highway Patrol met with myself and Detective Josh Bender at our office. We assisted Trooper Keeton with typing the charges and search warrant. Trooper Keeton was the affiant for the criminal charges and the search warrant for the Ford Fusion. Once that was finished our involvement with the investigation was complete.
