**Narrative:**

On Monday, March 24, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy) reviewed the crime scene photos regarding the personal clothing of Shawn Ware (Ware). Some of the clothing was photographed by Crime Scene Unit (CSU) SA Dan Boerner (Boerner) while on scene, while other clothing was photographed and documented upon receipt from the Cuyahoga County Medical Examiner's Office (CCMEO). The clothing was stored inside the BCI Richfield evidence room.

The clothing photographed by SA Boerner were placed into an evidence bag labeled as Matrix item #008. They are as follows:

1. Matrix evidence item #008 - Blue Jeans worn by Ware depicting one defect in the right front thigh area.
