On December 15, 2021, you and Officer Rosario Perez investigated a disorderly subject complaint involving the alleged victim, Angel Evans. Ms. Evans notified dispatch the suspect had pushed her and stated during your investigation he had put his hands on her. You failed to follow up on Ms. Evans' statements to determine if she had been assaulted by the suspect and wished to pursue criminal charges.

## PERFORMANCE RECOGNITION

6-21-2023 WRITTEN COMMENDATION

On June 21, 2023, you along with a multijurisdictional response, were dispatched to 400 Linden Avenue on a Disturbance complaint. This rapidly evolving situation quickly escalated into a homicide scene with multiple individuals discharging firearms. Your diligence, attention to detail and keen observation allowed for smooth transition from a chaotic scene into stability within the incident location. [REDACTED] your compassion, desire to serve the public, and dedication to your duties resulted in the preservation of critical evidence, and safety and security of all parties involved. Your efforts have brought great credit upon yourself, the Dayton Police Department, and the City of Dayton. I congratulate you on a job well done and you are highly deserving of this WRITTEN COMMENDATION.

3-20-2021 WRITTEN COMMENDATION

Sergeant Danielle Cash commended you for your actions on March 10, 2021, after you and several officers were dispatched to Sherriff Goslin Roofing, 2115 Valley Street on a male possibly trying to steal the catalytic converter off a truck. The businesses in that area had experienced a high number of thefts of this type so a perimeter was set up. Officers could hear the sound of metal being cut and other officers located a hole in the fence. After searching the area, you and other officers located a male suspect hiding under a pile of wooden skids. The suspect subsequently confessed to trespassing to steal the catalytic converters. Since the suspects arrest, there have been no additional thefts of this kind in the area.

4-26-2021 WRITTEN COMMENDATION

Lieutenant Stephen Clark commended you for your actions on March 27, 2021, after a shooting took place at the BP gas station at 2361 S. Smithville Road, Kettering, Ohio, which resulted in two people injured. Two Kettering Police Officers inside of the station at the time of the shooting requested a signal 99. Upon your arrival, you assisted Kettering PD in taking the suspect into custody and clearing his vehicle. You also rendered aid to the shooting victims one of which tragically succumbed to their injuries.

3-30-2021 WRITTEN COMMENDATION

Sergeant Terry Bartlett commended you for your actions on February 16, 2021, after you and Officer Rosario Perez responded to 25 Lombard Avenue Apartment B on a suspicious circumstances complaint that you found to be a physical fight between a male and female. The male refused to answer the door and could be heard coaching the female on her response leading you to believe the female may be being held against her will. You refused to leave and requested a supervisor respond. While waiting, you heard the female crying and pleading for help. Believing the female was in immediate danger, you and Officer Perez forced entry, freed the female and took the suspect into custody.

12-30-19 WRITTEN COMMENDATION

Lieutenant Randy Beane commended you for your actions on December 28, 2019, after Sergeant Terry Bartlett had a package stolen from his front porch and caught on his Ring doorbell camera. The camera video was sent out to East Patrol Operations Division officers and you immediately began searching the area for the suspect and vehicle. You located the suspect vehicle, however the suspect would not exit the house. Sergeant William Gross watched the house until the suspect exited and placed him under arrest.
