By this lease, which is one for a term of fifteen years and which provides for an annual rental of \$12.00, there is leased and demised to the lessee above named, the right to occupy and use for lawn, walkway and docklanding purposes only, that portion of the State Reservoir property at Indian Lake, that lies in front of Lot No. 14 of Waterbury's allotment, and being that portion of State land lying between the ordinary water line of Indian Lake and the westerly line of Lot No. 14; said lot having a frontage of forty feet and being a part of Virginia Military Surveys Nos. 10121, 9946 and 9925, Washington Township, Logan County, Ohio.

Upon examination of this lease, I find that the same has been properly executed by you as Conservation Commissioner and by the lessee. I further find, upon consideration of the provisions of this lease and of the conditions and restrictions therein contained, that the same are in conformity with Section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving this lease as to legality and form, as is evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof, all of which are herewith returned.
