**Narrative:**

On May 22, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente received a copy of the North Ridgeville Police Department (NRPD) Computer Aided Dispatch (CAD) report from NRPD Records Clerk Brenda Girgash. The CAD report was attached to this report.

SA Valente reviewed the CAD report and noted the following:

- On May 8, 2024, at approximately 1821 hours, the White County, Tennessee Sheriff's Office advised NRPD that Jason Norris (Norris) was the suspect in a homicide and should be considered armed and dangerous. Further, the vehicle Norris was suspected to be driving was actively being picked up on Flock cameras in the city of North Ridgeville. The NRPD dispatcher advised NRPD officers he/she ran the license plate of the vehicle, "773BLYZ," out of Tennessee and it returned to a 2024 Jeep Compass.
