### Narrative:

On August 24, 2023, the Ohio Bureau of Criminal Investigation (BCI) was requested to respond to an Officer-Involved Critical Incident (OICI) at 5991 South Sunbury Road in Westerville, OH. It was initially reported shots were fired by on officer from Blendon Township Police Department (BTPD) at this location and an involved individual was deceased.

Responding agencies to the OICI included the Franklin County Sheriff's Office (FCSO), Columbus Division of Police (CPD), Blendon Township Police Department (BTPD), Mifflin Township Police Department (MTPD), and Clinton Township Police Department (CTPD).

In response to the incident, multiple officers from the aforementioned agencies canvassed the area and obtained information and statements from witnesses. BCI Special Agent Kyle Douglass (SA Douglass) collected information obtained during the canvass.


