#### Narrative:

On Tuesday, April 08, 2025, at 1000 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (SA Goudy) and SA Eric Lehnhart (SA Lehnhart) interviewed Ravenna Police Department (RPD) Officer (Ofc.) (Brock Wise), who was accompanied by his attorney, Thomas M. Hanculak, from the Fraternal Order of Police. The interview took place at 1360 S.O.M. Center Road, Mayfield Heights, Ohio 44124. The interview was audio and video recorded.

Ofc. Wise read, understood, and signed the BCI Criminal Investigation Notification form.

This report only summarizes the information deemed by the author to be of the most relevance to the investigation and does not purport to contain all questions and answers from the interview. Further, this report was placed in chronology to aid the reader's overall understanding of the information elicited during the interview and may not be reflective of the actual sequencing of questions. It is suggested that the full recording be reviewed to clarify any content or contextual questions regarding the information from the interview.

### Narrative:

Officer Brock Wise (Officer Wise), Badge #429, is a 5-year veteran of the Ravenna Police Department (RPD) who began his employment on August 9, 2020. He is currently assigned to the patrol unit and is also a member of the Metro Special Weapons and Tactics Team (SWAT), as a tactical operator. He is OPOTA certified through the University of Akron Police Academy and is up to date on all required training and qualifications.

On Sunday, March 16, 2025, Officer Wise, while on station, was dispatched to the area of 645 Hazen Avenue, Ravenna, Ohio 44266 for a man with a gun. This address was an apartment complex that Officer Wise was at approximately twenty (20) minutes earlier for a menacing call.

Officer Wise arrived at the complex just prior to Sergeant Cris Coy (Sgt. Coy). As the two approached apartment #1, the complainant Terry Conway (Conway) opened the apartment door. With the door open, Officer Wise could see the subject, who was immediately identified as Shawn Ware (Ware) lying on the ground, facing the door with a firearm (pistol) in his right front pants pocket. Ware sat up from his position and grabbed the weapon as Officer Wise gave commands to not touch the gun. Officer Wise drew his service weapon and pointed it in the direction of Ware.

At that time, Conway was able to retreat to the living area to the left of Officer Wise while Ware was rising to his feet with the gun in his right hand. Officer Wise continued to give verbal commands to Ware who was defiant to those commands. Officer Wise moved to a position of cover as the door closed and he lost visual contact with those inside the apartment.

With the door now closed, Officer Wise "retreated" up the stairs in a position where he could still see the door to apartment #1, and Sgt. Coy moved to a better position down the hall towards a room later identified as the "laundry" room. Although the door to the apartment was closed, Officer Wise continued to give verbal commands to Ware to drop the gun and exit the apartment with his hands up.

A moment later, the door to apartment #1 opened and Ware and Conway appeared. Ware had one arm around Conway's chest/neck with the gun in the opposite hand

pointed towards Conway's head. Officer Wise stated that he could hear Conway shout "don't shoot me, please don't shoot me."

Although Officer Wise wasn't sure how, Conway managed to break free from Ware, turned and retreated inside the apartment. According to Officer Wise, Ware noticed Sgt. Coy down the hallway and began to move towards his position. Officer Wise then heard a gunshot but was not confident whose weapon it came from. In turn, Officer Wise fired four (4) times in the direction of Ware. Ware was seen failing to the floor with the gun still in his right hand. With Officer Wise covering Ware, Sgt. Coy moved to secure Ware's gun. Once Ware's gun was secured, Sgt. Coy stayed with Ware as Officer Wise retrieved a trauma kit and first aid was rendered to Ware until the Ravenna Fire Department arrived to assume medical care of Ware.

Officer Wise was accompanied to his patrol vehicle by a Kent Police Officer. The pair stayed at Officers Wise's vehicle for fifteen (15) minutes until Officer Wise was transported to University Hospitals Portage Medical Center for evaluation.

The interview concluded at approximately 1058 hours.
