Narrative:

On Monday, July 21, 2025, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman received requested records and recordings from Middletown Deputy Police Chief Ryan Morgan. SA Seitzman had previously requested all dispatch records, audio recordings (radio, 911, and phone), mobile data terminal communications, and any other dispatch/communications-related information relevant to the July 13, 2025, officer-involved critical incident. As a result of that request, the following items were received and reviewed:

Computer-Aided Dispatch Information

The CAD record indicated that the call for service was received on July 13, 2025, at 1642 hours. The initial call for service note read, "FEMALE GSW UNK WHERE."

911 Phones Calls

SA Seitzman reviewed two audio-recorded 911 calls the Middletown Police Department received from Justin Newcomb. The audio recording began with a computerized voice indicating the date and time, which was July 13, 2025, at 16 hours, 42 minutes, and 53 seconds. Mr. Newcomb began by excitedly telling the dispatcher, "My neighbor just shot his wife. Get them here now." Mr. Newcomb relayed that the incident location was at 3013 Mohawk Steet, and that there was a van and a red SUV parked on the driveway. The dispatcher inquired where the victim was shot. Mr. Newcomb explained that he was uncertain and that he obtained his information from the victim's son, who had rushed over to his residence. Mr. Newcomb asked the victim's son where the incident occurred, to which he answered that it happened in the living room. Mr. Newcomb ended the conversation by telling the dispatcher to "get the cops here now...Like now. Get them here now."

SA Seitzman reviewed a second 911 call from Justin Newcomb. This recording began with a computerized voice indicating the date and time, which was July 13, 2025, at 16 hours, 46 minutes, and 19 seconds. Mr. Newcomb advised the dispatcher to "never mind," as the police had just arrived.

Radio Traffic Recordings

The radio traffic did not provide any additional information not previously discovered through other investigative processes. According to Middletown Deputy Chief Ryan Morgan, it appeared the initial responding officers self-dispatched to the call, which he advised was a common practice. Deputy Chief Morgan indicated that officers can typically access a pending call for service on their in-car mobile data terminals as dispatchers input the pertinent information to dispatch the call via radio.

Mobile Data Terminal Communications:

No communications were located.

The records and recordings received were stored on Evidence.com within the folders labeled "Reference Item A – 911 Calls" and "Reference Item B – Radio Traffic." The computer-aided dispatch report is attached to this investigative report. Also attached are the Middletown Police Department's searches regarding relevant mobile data terminal communication.
