## Summary:

On April 13, 2022, two cellular phones were received from Special Agent John Lieber of the Major Crimes, Special Investigations Unit. These two cellular phones were recovered from the scene of a Fatal Officer Involved Shooting in Ashtabula, Ohio.

On April 20, 2022, a Search Warrant was obtained through the Summit County Court of Common Pleas, for the search of the two cellular phones. The search warrant was signed by the Honorable Judge Kelly L. McLaughlin for the criminal offenses in violation of the Ohio Revised Code of Felonious Assault 2903.11 and Aggravated Menacing 2903.21

This device was received in an uncharged condition, the SIM Card was removed. Upon charging the device its was shown to be powered on and unlocked. Cellebrite UFED4PC Mobile Forensic Software was used to conduct the analysis of this device. Two extractions were performed,

Advanced Logical and a File System. These were completed without error. Both extractions were combined for the purposes of analysis. All recovered image and multi-media files were examined with no data of evidentiary value was noted. The call logs were reviewed and the last call date noted on this device was March 26, 2022. All recovered instant messages were reviewed with the last message date of March 26, 2022. One instant message shows the date of April 25, 2022, upon analysis of this message it appears this message was part of the last message dated March 26, 2022 and was not completed or sent before the phone lost power or was powered off. Once the phone was charged/powered the phone attempted to send the message but was unable to because the SIM Card was removed. All recovered Facebook data was reviewed with negative results for any data of evidentiary value. This device was negative for any recovered internet history.

The SIM Card data was reviewed with negative results for any data of evidentiary value.

Cellebrite UFED4PC Mobile Forensic Software was used to conduct the analysis of this device. Two extractions were performed, Advanced Logical and a File System. These were completed without error. Both extractions were combined for the purposes of analysis. All recovered image and multi-media files were examined with no data of evidentiary value was noted. The call logs were reviewed and three calls of interest were noted, these calls were all dated for April 13, 2022:
