Narrative:

On October 28, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) completed a review of the video captured from the body-worn camera (BWC) of Officer Dallas Guyton (Officer Guyton) during this incident. Officer Guyton created three separate BWC videos relevant to this investigation and all three videos were reviewed as noted below.

Amped Replay was used to review the videos.

SA Valente made working copies of the three BWC videos and placed the copied videos in a folder on his BCI issued laptop. The working copies of the videos were used for the review.

As Ferrel Thomas approached Officer Guyton, Ferrel Thomas said something that began unintelligible and included, "He's high. Fuckin' high. Fuckin' high and he don't know what the fuck is goin' on." As Ferrel Thomas made that statement, officers were communicating with their dispatchers via police radio to have an EMS squad respond and stage somewhere within close proximity to their location.

Once Ferrel Thomas reached the officers staged near the front right of his home, he continued, "Do not [unintelligible] my son if you don't have to. He's got a fuckin' loaded weapon. He's got a loaded weapon." A voice consistent with Officer Ondercin's replied to Ferrel Thomas telling him he knew the subject was armed and wanted Ferrel Thomas to exit the home to avoid further upsetting the subject. While this conversation was happening, other officers and dispatchers continued communication through the police radio. A voice, believed to be the subject's, then appeared to yell out loudly from the front of the home, "Nooooooo. Nooooooo."

Note that, as Ferrel Thomas was speaking, he was standing behind Officer Ondercin, whose attention appeared to be directed at the front door of the home, where the subject was reported to be standing and yelling from.

Ferrel Thomas and Genisis Thomas continued to discuss the situation. Ferrel Thomas told his daughter he was not arguing with the subject, rather that the subject was high. Officer Ondercin reported over the police radio that the subject was believed to be the only person left in the house. As Officer Ondercin finished that statement, Ferrel Thomas could be seen on the video telling Genisis Thomas something that began unintelligible and included, "Walking around waving a gun high as fuck in our fuckin' house." The conversation between Ferrel Thomas and Genisis Thomas was drowned out by officers communicating over their police radios.

Ferrel Thomas began to cry and asked that officers don't let his son die. Officer Guyton escorted Ferrel Thomas away from the subject and towards the road where his two daughters were then standing. Ferrel Thomas briefly walked away then reapproached Officer Guyton and apologized.

Officer Guyton then secured the area with crime scene tape, provided security around the scene and began a scene log.

All frames referenced above, except for the start time and end time frames, were bookmarked as images in Amped Replay. The images were exported to the folder "Ofc. Guyton BWC 1 Derivatives and Reports."

An Amped Replay report was generated for Officer Guyton's first BWC video review and bookmarked images. The report was exported to the same folder noted above. Ferrel Thomas made a comment to the police officers that he should have remained inside the home with the subject rather than leaving the home. The video ended as Ferrel Thomas and a Cleveland Heights Police Detective spoke with each other. The audio quality was not clear enough to determine with certainty what was said during the conversation. No derivative works were produced during the review of this video.

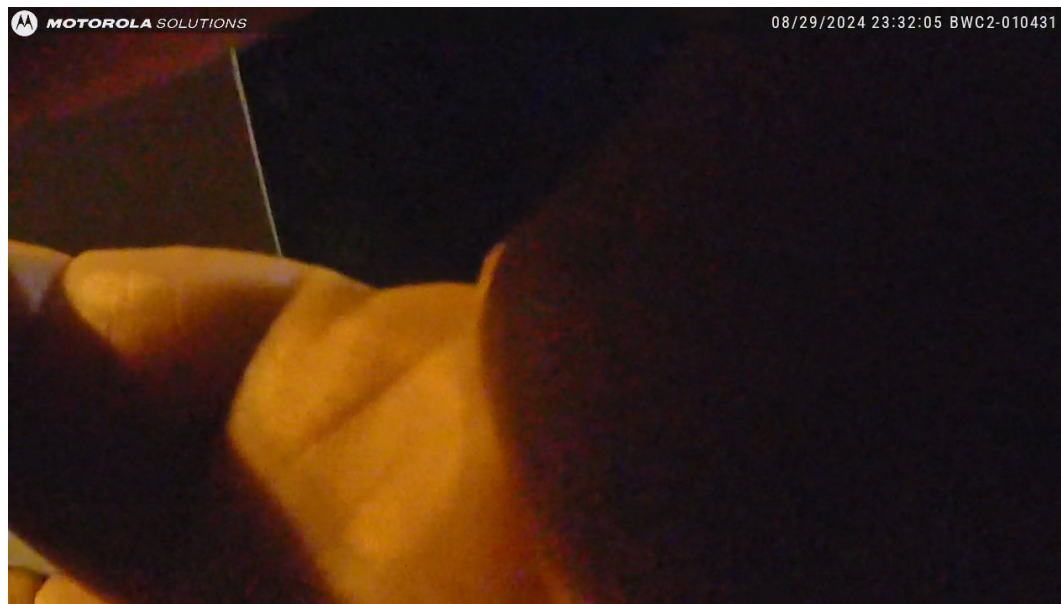
