Narrative:

On Tuesday, March 4, 2025, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman received the training records for Miami Township Police [REDACTED] from Assistant Chief James McCarty. SA Seitzman reviewed the training records and noted the following:
