Narrative:

On October 19, 2024 at approximately 1920 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent Dave Hornyak contacted the Oakwood Police Department (OPD) to identify an OPD officer who was reported to have responded to the scene of an Officer-Involved Critical Incident that occurred earlier that day in Dayton, Ohio. OPD Dispatch identified Public Safety Officer Rob Wilson as the responding officer and SA Hornyak was transferred to the officer's phone. After agreeing to speak with the agent on a recorded phone call, Officer Wilson then provided the following information:

Officer Wilson is a Public Safety Officer for the Oakwood Police Department, which means he is a police, fire, and paramedic specialist. Earlier on October 19, 2024, he responded to a countywide call for officer assistance in Dayton, Ohio. He arrived near the reported location at Rosedale Avenue and observed that multiple agencies were already on-scene. Assisting officers were asked to block roadways. As Officer Wilson attempted to do so he met up with an unknown Montgomery County deputy on Windsor Avenue when he then heard shots fired. Officer Wilson verified that he did not see any of the shooting incident and only heard the shots.

Being a medic, Officer Wilson approached the scene where he found Dayton Police Department officers rendering aid to a subject who appeared to have multiple gunshot injuries to the right side of his body. Officer Wilson handed the officers a large wound dressing from his trauma kit, which was then applied to the subject. Officer Wilson next used his stethoscope to check for lung sounds and a heartbeat. Hearing none, he started CPR, which continued until Dayton fire arrived and took over critical care. Officer Wilson specified that Dayton Police Department officers acted quickly in rendering aid to the subject.

As he had no direct involvement with the actual shooting, Officer Wilson stated that he will not be completing an incident report for his agency. The interview was then terminated at

approximately 1930 hours.
