Narrative:

On Tuesday, November 19, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Josh Rammel (SA Rammel) compiled background information on involved juvenile Calvin Darapheth (Calvin) regarding the Officer Involved Critical Incident (OICI) on October 28, 2024. The information included researching past police reports involving the subject, searching criminal history records (if applicable), and open/closed-source database inquiries. The information gathered was obtained from the BCI Criminal Intelligence Unit and the Findlay Police Department (FPD).

SA Rammel reviewed the information and noted the following:

Prior Police Encounters:

1. On February 12, 2022, Calvin was charged with Improperly Discharging a Firearm at or into a Habitation or School in violation of Ohio Revised Code (ORC) 2923.161, a Felony of the Second Degree. Calvin admitted to firing his father's .22 caliber long rifle into his neighbor's house. See FPD report [REDACTED].
2. On February 28, 2022, Calvin was charged with Marijuana Possession in violation of ORC 2925.141, a Minor Misdemeanor (MM). Calvin was found in possession of a THC vape pen while at Findlay High School. See FPD report [REDACTED].
3. On May 1, 2022, Calvin was charged for Assault in violation of ORC 2903.13, a Misdemeanor of the First Degree (M1). Calvin and two unknown juveniles physically assaulted another juvenile. Calvin admitted to hitting the juvenile in the face for "snitching" on him. Calvin refused to provide the identities of the other involved juveniles. See FPD report [REDACTED].
4. On October 27, 2022, Calvin was charged as an Unruly Juvenile in violation of ORC 2151.022, a MM. Calvin was arrested on October 31, 2022, pertaining to

the Unruly Juvenile offense stemming from Calvin being listed as a runaway. See FPD report [REDACTED].

5. On January 20, 2023, Calvin was charged with Assault in violation of ORC 2903.13, an M1. Calvin and another juvenile got into a mutual fight at Findlay High School. See FPD report [REDACTED].
6. On March 29, 2023, Calvin was charged for Theft of a Motor Vehicle in violation of ORC 2913.02, a Felony of the Fifth Degree (F5); and Receiving Stolen Property in violation of ORC 2913.51, an F5. Calvin and another juvenile were charged for stealing a 9mm firearm and a car from the other juvenile's mother. See FPD report [REDACTED].
7. On October 10, 2024, Calvin was charged with Theft in violation of Findlay Municipal Code (FMC) 545.05A1, Complicity in violation of FMC 501.10A2, and Complicity in violation of ORC 2923.03; all M1's. Calvin and three additional individual were involved in shoplifting a bottle of alcohol from a Walmart location in Findlay. See FPD report [REDACTED].

Once I gained permission from his mother I asked Calvin what happened. Calvin advised he was in the cafeteria and Estavon came up to him and started running his mouth trying to fight him. Calvin advised yesterday he heard that Estavon was going to try and fight him at school today. Calvin advised Estavon got into his face and said he wanted to fight him. Calvin advised he was trying to avoid the situation but Estavon advised to meet him in the bathroom. Calvin advised he then willingly went to the bathroom and when he entered the bathroom Estavon started throwing punches at him. Calvin advised that he threw punches back at Estavon. I asked Calvin if he knew it was going to be a fight in the bathroom and he advised that he did. It appeared Calvin got hit in his eye due to being red and swollen. I asked Calvin if Estavon was in the bathroom first waiting on him and he advised that he was. I asked Calvin if he wanted to pursue charges and he advised that he did. I asked Calvin if this was a mutual fight and he advised that it was. Calvin provided a written statement.

I then spoke to Estavon Williams. Estavon attempted to contact his father but received no answer. Estavon was able to contact his grand mother who advised she does not talk to Estavon's father. Estavon advised he had heard that Calvin was talking bad about him outside of work. Estavon advised Calvin was calling him and his friend a pedophile. Estavon said that Calvin kept saying he don't like Estavon and will fight him when he see's him. Estavon said that Calvin kept threatening to kill him and stab him if he see's him. Estavon advised when he saw Calvin he assumed Calvin wanted to fight. Estavon advised he is a man and ain't scared to fight. Estavon advised Calvin kept saying let's go to the bathroom. Estavon advised he then went to the bathroom where Calvin was waiting for him. Estavon advised Calvin threw a punch first so he fought Estavon. I asked Estavon if this was a mutual fight and he advised that it was. I asked Estavon if he wanted to pursue charges for menacing or assault and he advised that he did not.

I asked security if they had video of the altercation and they advised that they did not due to it occuring in the restroom. I asked security who was in the bathoom first and they said Calvin was in the bathroom waiting on Estavon.

Notes The firearm functioned and fired a projectile as designed.

On Saturday February 12, 2022 at 1310 hours, Officer D Kliesch #1135 and I were dispatched to 628 College St. for a reported damage to property. Upon arrival, I came into contact with the caller, Kenneth Silvers. Kenneth explained that at some point between 0830 and 1310 on 02/12/2022 he noticed damage to his residence that he believed to be from a gunshot.

I observed a small hole in the siding on the north side of the residence. Inside, I observed a small hole with white dust around it as well as a hole through a jacket. Across from the hole inside the residence was a noticeable hole in a kitchen cabinet. Inside the residence directly below the jacket, I noticed what appeared to be a fired .22 bullet. This was collected and later placed into Police Property. The direction of the holes indicated that the fired round came southbound. All holes were approximately five and half feet high. All damage to the residence was photographed.

I stopped at the residence directly to the north, 629 Davis St. I met with the owner, Thang Darapheth. I explained that Kenneth had called to report a possible gun shot fired into his residence. I asked Thang if there were any weapons in his home. Thang informed me that he did own a .22 rifle. I asked if we could step inside to view the firearm to which Thang agreed. Thang retrieved the firearm which was stored in an unsecured closet in the living room in a soft shell case. Inside the case was a black rifle and unsecured ammunition. The rifle was a Mossberg int'l 702 plinkster .22 caliber rifle (EEH208879). I spoke to Thang's son, Calvin Darapheth (age 15). Calvin admitted that between the hours of 0900-1000 on 02/12/2022 he took the rifle into the back yard and fired a round. He told me that he had "no intention of hurting anyone. He didn't even know how to aim the gun. He never fired a gun before and wanted to see what it was like". Calvin showed me where he stood and the direction he faced when he fired the rifle. Calvin's statement corroborated with the damage found at 628 College St. Calvin is a ninth grader at Findlay High School with no prior offenses.

I noticed a .22 caliber casing against the foundation of the east side of the residence next to where Calvin was standing when he fired the rifle. This was collected and later placed into evidence. The firearm was seized for evidence along with a single .22 round and later placed into Police Property to be test fired.

I will be requesting a charge of Improperly discharging firearm at or into a habitation (ORC: 2923.161A1) a felony of the second degree due to discharging a firearm at or into an occupied structure that is a permanent or temporary habitation of any individual on Calvin Darapheth.

On Saturday February 12, 2022 at 1310 hours, Officer D Kliesch #1135 and I were dispatched to 628 College St. for a reported damage to property. Upon arrival, I came into contact with the caller, Kenneth Silvers. Kenneth explained that at some point between 0830 and 1310 on 02/12/2022 he noticed damage to his residence that he believed to be from a gunshot.

I observed a small hole in the siding on the north side of the residence. Inside, I observed a small hole with white dust around it as well as a hole through a jacket. Across from the hole inside the residence was a noticeable hole in a kitchen cabinet. Inside the residence directly below the jacket, I noticed what appeared to be a fired .22 bullet. This was collected and later placed into Police Property. The direction of the holes indicated that the fired round came southbound. All holes were approximately five and half feet high. All damage to the residence was photographed.

I stopped at the residence directly to the north, 629 Davis St. I met with the owner, Thang Darapheth. I explained that Kenneth had called to report a possible gun shot fired into his residence. I asked Thang if there were any weapons in his home. Thang informed me that he did own a .22 rifle. I asked if we could step inside to view the firearm to which Thang agreed. Thang retrieved the firearm which was stored in an unsecured closet in the living room in a soft shell case. Inside the case was a black rifle and unsecured ammunition. The rifle was a Mossberg int'l 702 plinkster .22 caliber rifle (EEH208879). I spoke to Thang's son, Calvin Darapheth (age 15). Calvin admitted that between the hours of 0900-1000 on 02/12/2022 he took the rifle into the back yard and fired a round. He told me that he had "no intention of hurting anyone. He didn't even know how to aim the gun. He never fired a gun before and wanted to see what it was like". Calvin showed me where he stood and the direction he faced when he fired the rifle. Calvin's statement corroborated with the damage found at 628 College St. Calvin is a ninth grader at Findlay High School with no prior offenses.

I noticed a .22 caliber casing against the foundation of the east side of the residence next to where Calvin was standing when he fired the rifle. This was collected and later placed into evidence. The firearm was seized for evidence along with a single .22 round and later placed into Police Property to be test fired.

See Ofcr Stoner's #2043 case supplement for test fire.

I will be requesting a charge of Improperly discharging firearm at or into a habitation (ORC: 2923.161A1) a felony of the second degree due to discharging a firearm at or into an occupied structure that is a permanent or temporary habitation of any individual on Calvin Darapheth.

NARRATIVE

On 02/13/2022, Sgt. Deidrick #425 requested that I test fire a firearm for this case left in property locker #40 by Ofcr. Davis #450.

I removed the firearm from the property locker. The firearm was stored in a soft rifle case. I found the firearm to be a black colored Mossberg Int'l 702 Plinkster chambered in .22 caliber long rifle. The serial number on the rifle was EEH208879.

I took the firearm to the City of Findlay Indoor Firing Range with a .22 caliber long rifle cartridge that I obtained from the police departments supply of ammunition. Before placing the cartridge into the chamber, I took a permanent marker and drew a ring completely around the cartridge's case to make the cartridge unique so that it could be positively identified after firing the rifle. I placed the cartridge into the rifle's chamber and test fired the rifle, aiming it at a Findlay Police Test Fire Evidence Sheet. The firearm fired the cartridge, the projectile left a hole in the paper, and the rifle ejected the spent casing. The firearm functioned and fired a projectile as designed. I collected the .22 caliber long rifle casing off the range floor and found that it had the same ring that I had previously drawn on it with the permanent marker.

I made sure the firearm was safe and secure and placed it back into the rifle case. A copy of the test fire sheet was made to provide to Ofcr. Davis. The original test fire sheet and spent casing were sealed in an envelope and placed in the rifle case with the rifle and returned to locker#40 and secured. This ended my involvement.

NARRATIVE

On 10/10/24 at approximately 1836 hrs I was dispatched to 2500 Tiffin Ave (Walmart) for a theft in progress. The caller, Aylissa Shoemaker, advised four suspects who she believed to be teenagers just stole alcohol. Aylissa is a loss prevention employee with Walmart. Aylissa said the suspects fled in a tan Chevrolet heading westbound on Tiffin Ave.

While in route, I was unable to locate the suspect vehicle. Upon arrival at Walmart, I made contact with Aylissa. Aylissa said she recognized the four suspects from a previous theft earlier in the week. Aylissa said she did not report the incident earlier this week because she was too busy at the time.

Aylissa showed me a still image of the suspect vehicle, which was caught from a Walmart security camera. The vehicle was a tan Chevrolet Malibu with Ohio license plate KHN5744. Aylissa showed me more still images of the suspects. I observed a white female wearing a black shirt with blue jeans, a white male wearing a blue t-shirt with jeans, a white male wearing a white sweatshirt with pajama pants, and a dark-skinned male wearing a purple sweatshirt with jeans. All suspects appeared to be in their late teens. Aylissa showed me surveillance footage of the four suspects walk into Walmart together. The female then separated from the males once inside. When walking through a liquor aisle, I observed the male wearing a purple sweatshirt grab a bottle of Hpnotiq alcohol from a shelf and walk away with it.

Aylissa began following the juveniles once they entered the store due to her prior knowledge of them stealing. Aylissa said she observed the suspect in the purple sweatshirt walking towards the exit with the bottle of Hpnotiq in his hand. Aylissa said the male placed the Hpnotiq in his sweatshirt to conceal it as he walked past all points of sale without offering payment for the alcohol. The female rejoined the males as they began walking towards the exit. Aylissa said she confronted the four suspects and asked them to come with her to the loss prevention office. Aylissa said the female suspect asked Aylissa why she wanted them to stop. Aylissa said she told the female it was because they were stealing a bottle of liquor and they were under 21 years of age. Aylissa said the female told her she was over 21 years of age. Aylissa said she needed them to stop because they were stealing. Aylissa said the female suspect became verbally aggressive and began cursing at her before all suspects finally exited the store. Aylissa said the female suspect was the one who drove the Chevrolet away from Walmart.

Aylissa said she wished to pursue criminal charges for ORD 545.05A1 -- Theft against the suspects, as well as having them trespassed from all Findlay Walmart locations. Aylissa completed a written statement. I sent Aylissa a community request link, which she later used to upload photos and videos of the suspects. I accepted these to Evidence.com. Aylissa provided a receipt for the stolen item, which listed the Hpnotiq bottle priced at \$19.98. I attached a copy

of this receipt to the report.

Upon running Ohio license plate KHN5744 through LEADS/BMV, I found the owner of the Chevrolet was Bianca Meloche who lived at 2180 Bluestone Dr. I later identified Bianca as the female suspect from this theft. I stopped out at 2180 Bluestone Dr and did not observe the Chevrolet in the driveway. I made contact with a female at this location who I identified as Sherri Zifko. Sherri advised Bianca was her granddaughter and they lived at this location together. I showed Sherri a photo of the four suspects and asked if she could identify any of them. Sherri identified Bianca as the female suspect. Sherri said she could not identify the other suspects. Sherri called and asked Bianca where she was. Bianca said she was in Bowling Green. Sherri told Bianca that officers were at her door asking about the theft at Walmart. Bianca began screaming that she did not steal anything from Walmart. I attempted to explain to Bianca that she did not steal anything, but she was involved with the other three suspects who did steal the liquor bottle. Bianca continued to scream at me and say she knew nothing about this incident. Bianca eventually advised she did not wish to speak with any officers and would be seeking a lawyer. I advised Sherri that she could contact me in the future if she identified the other suspects.

Prior to the end of my shift, I entered a BOLO requesting any officer who could identify the suspects to email me.

On 10/11/24, I was notified by Officer Hernandez #882 that he identified the male in the white sweatshirt as Aiden Ansel. Officer Hernandez advised he trespassed Aiden from another location earlier today. Officer Hernandez said he advised Aiden's mother, Nicole Ansel, that I would be attempting to contact her in regards to this incident. I stopped out at Aiden's address of 238 Garfield Ave and made contact with Nicole. I showed Nicole the photo of the theft suspects, and Nicole identified Aiden as the male in the white sweatshirt. Nicole could not identify any of the other suspects. Nicole said she did not know where Aiden was at this time, and that she would be reporting him as missing if he did not return by midnight tonight. Nicole said Aiden did not have a phone with him because he broke his.

On 10/12/24 I stopped out at 238 Garfield Ave and made contact with Nicole and Aiden. I asked Aiden if he would tell me who were the three suspects he was with during this incident. Aiden said he only knew the females name was Bianca, but he did not know the other males. Aiden said he did not know the unidentified male was going to steal the liquor bottle until they entered Walmart. Aiden admitted to knowing the theft was going to occur as he walked with the male suspects towards the liquor aisle. I advised Aiden he was trespassed from both Findlay Walmart locations, and he would be charged with criminal trespass if he returned. Aiden said he understood.

I attempted to call Bianca, but received no answer. I called Sherri, who advised after I spoke with her on 10/10/24, she told Bianca she could no longer live at this location if Bianca did not cooperate with the police. Sherri said Bianca has since moved out and she does not know where she is. Sherri said she would try and call Bianca to let her know I was trying to contact her. I later followed up with Sherri, who advised Bianca said she did not want to speak with police. Sherri said she told Bianca that she was not allowed to return to Walmart, and Bianca said she understood. Officer Jolliff left Bianca several voicemails asking for her to contact us in order to be issued a trespass. Bianca did not answer or return any calls. If Bianca is contacted her trespass warning will be issued and a supplement added. If the two unknown suspects are identified a supplement and charges will be completed. An alert was added to LERMS reference Aiden's trespass warning.
