Narrative:

On Wednesday, March 19, 2025, at approximately 0526 hours, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman interviewed Hamilton County Sheriff's Office Corporal Shane Wiseman. The interview took place at the scene in SA Seitzman's agencyissued vehicle. The interview was audio recorded.

The details below summarize what the author believed to be the pertinent portions of the recorded interview and are not a verbatim account. Further, this report was placed in a chronology to aid the reader's overall understanding of the information elicited during the interview and may not be reflective of the actual sequencing of questions. It is suggested that the full audio recording be reviewed.

Cpl. Wiseman was identified as being a deputy who witnessed and/or had some level of involvement in the officer-involved critical incident that occurred on the same date in the area of Interstate Route 75 North near mile marker 14. Cpl. Wiseman advised that he did not discharge his firearm. The purpose of the interview was to obtain all relevant information known or observed by Cpl. Wiseman. He confirmed that he was providing his statement voluntarily.

Cpl. Wiseman advised that he began as a deputy with the Hamilton County Sheriff's Office in 2013. He began his law enforcement career in 1998. Prior to working for the sheriff's office, he worked for the village of Maineville and village of Waynesville police departments. He has been assigned as a canine officer for the past three and a half years. He advised that he works He was driving a marked Hamilton County Sheriff's Office Chevrolet Tahoe. Through other records, it is known that his radio call sign was "9-William-42." He was wearing his department-issued deputy sheriff uniform, which consisted of Ohio Deputy shoulder patches, Corporal chevrons, an external load-bearing ballistic vest, and a sheriff's star badge, and other proper markings. He considered himself

well-represented as a deputy sheriff during the incident.

Cpl. Wiseman advised that during the early morning hours, he listened to radio traffic regarding a pursuit out of West Chester Township in Butler County. He advised that West Chester police officers terminated the pursuit; however, Sharonville officers spotted the fleeing vehicle near Sharon Road and Mosteller Road and began to pursue it. He advised that Sharonville eventually terminated their pursuit of the vehicle.

Cpl. Wiseman advised that sometime around 0300 hours, an Evendale police officer located the vehicle that had just fled from officers crashed in the area of Evendale Drive and Glendale Milford Road. He stated that the vehicle had been located with all of its doors opened. He advised that he was dispatched at that time due to him having a canine. He said he was already in the area. As he was responding to the crash scene, a Glendale police officer in front of him located a subject (later identified as Charles Jackson) jumping over a guardrail on Glendale Milford Road near Aviation Way. He relocated and deployed his canine. The subject was then located in the woodline and was taken into custody by either an Evendale or Sharonville police officer. He described Charles Jackson as a Black male wearing a gray sweatshirt.

Cpl. Wiseman continued searching after the arrest of Charles Jackson. As he was searching, a Lockland police officer broadcast that he had located a subject walking on Interstate Route 75 North. He advised that he was close to the location of the Lockland police officer, so he responded in that direction. As he was responding, the Lockland police officer broadcast that the subject he was out with was not compliant. The Lockland police officer then asked for the responding back up to "step it up." At that point, Cpl. Wiseman began running faster. As he was approaching, he believed that the Lockland police officer had deployed his TASER. He clarified that he did not see the Lockland police officer actually deploy the TASER, but he observed evidence of TASER usage later. As he got approximately 10 yards away, he began announcing, "Get on the ground, or you're going to get bit!" As he got near, the Lockland police officer began backing up as the involved subject was advancing toward him. Cpl. Wiseman then observed the Lockland police officer fire an estimated five or six shots. He stated that he was approximately five to ten yards away from the Lockland police officer and involved subject at that point.

SA Seitzman asked Cpl. Wiseman if he observed any objects in the involved subject's hands. He stated that he was initially unable to see his hands; however, he said that the involved subject fell face first after the shots, then rolled onto his back. At that point, he was able to see that the involved subject had a black metal rod, approximately two feet long, clenched in his right hand. Cpl. Wiseman stated that he believed the metal rod the involved subject possessed was an instrument capable of inflicting serious bodily harm and/or death.

Cpl. Wiseman advised that he instructed a Glendale police officer to commence life-saving measures. He clarified that he was unable to provide hands-on medical assistance due to handling a canine. The Glendale police officer began checking for wounds; however, he did not initially identify any. The Glendale police officer then cut the clothes off of the involved subject. He recalled another officer arriving with a medical kit, at which point they observed blood on the involved subject's chest. The officers placed a chest seal over the wound. The officers then located another wound on one of the involved subject's legs and applied a

tourniquet around the leg. Cpl. Wiseman indicated that he did not observe any signs of life in the involved subject.

Cpl. Wiseman said he did not converse with the involved Lockland police officer, though he did observe that the officer seemed distraught.

The interview concluded at 0541 hours.
