Summary:

On January 10, 2023, Special Agent (S/A) William Conn received one cellular phone from Special Agent Nick Valente of the Special Investigations Unit. S/A Valente stated he recovered the cellular phone from the scene of an Officer Involved Critical Incident. The accompanying search warrant was signed by the Honorable Judge Kelly McLaughlin of the Summit County Court of Common Pleas for the criminal offenses of 2903.11 (Felony Assault) and 2921.331 (Failure to Comply with Order or Signal of a Police Officer) in violation of the Ohio Revised Code.

S/A Valente requested the cellular phone be downloaded for content. S/A Valente also requested all recovered chat between the dates of December 22, 2022 and December 26, 2022 be exported as well as any recoverable data related to the following names:

Narrative:

Item 003 is a Samsung Galaxy Cellular Phone

Model SM-A1236U

IMEI 356424985036856

Passcode 4629

Upon receipt of **Item 003** it was found to be passcode protected. Mobile forensic software was used to unlock this device and recover the passcode; this effort was successful. The recovered pass code is █████ as listed. Upon successful unlock, a Full File System Extraction was conducted on **Item 003**. This was completed without error.

Cellebrite's Physical Analyzer Mobile Forensic Software was used to conduct to analysis of **Item 003**. As requested by S/A Valente, all recovered chat / IM messages between December 22, 2022 and December 26, 2022 were bookmarked and a PDF Format Report was created of recovered data. All recovered Facebook Messenger data was reviewed with negative results for any items of evidentiary value. The above listed names were searched and the following results were noted:

1. Jason Plants – negative for items of evidentiary value
2. Pamela Stratford – negative for items of evidentiary value
3. Christie Stephens – PDF Report created of recovered information.
4. James Greathouse – PDF Report created of recovered information.
5. Sherry McCrossin – PDF Report created of recovered information.

Conclusion:

Item 003 was downloaded as requested and an overall Cellebrite Reader Report was created of all recovered content.

As listed above PDF Reader Reports were created of all recovered data as requested.
