Narrative:

On Wednesday, June 08, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agents John Butterworth (SA Butterworth) and Matt Collins (SA Collins) conducted a neighborhood canvass in the area of Agler and Stelzer Roads, Columbus, Ohio. The purpose for the canvass was to identify and interview potential witnesses to the officer-involved shooting that occurred at 2280 Stelzer Road, Columbus, Ohio on Tuesday, June 07, 2022. During the neighborhood canvass, Special Agents Butterworth and Collins made or attempted contact with the residents at the following addresses:

Boost Mobile, 2280 Stelzer Road, Suite A

SA Butterworth stopped and spoke with the employee on duty, Diamaunte Hale, and spoke with him regarding the surveillance cameras on the store. According to Hale, no cameras point in the direction of the incident and if anything were to be on the cameras, they will be sure to contact SA Butterworth. A business card was left from SA Butterworth at the store and Hale was advised if anything further were to be on the cameras to please advise. Hale said he would have the store manager check and get back if anything is found. As of August 4, 2022, no further information has been forwarded.

Sahal Haal Grocery, 2280 Stelzer Road, Suite B

SA Butterworth stopped and spoke with the owner, Ali Hange, about the incident and the surveillance cameras he has on the store. According to Hange, he did not have any cameras that pointed in the direction of the incident. Hange showed SA Butterworth his camera system and it did not have an exterior view of the area of the incident that occurred outside the building.

3734 Armuth Ave., Columbus, OH

SA Butterworth and SA Collins stopped at this address and knocked several times on the front door. No one answered the door at the time and it appeared as if no one lived at the residence at the time. There were no surveillance cameras around the property that were able to be seen.
