Narrative:

On November 11, 2023, Special Agent James Poole (SA Poole) reviewed the surveillance video footage provided by the Kroger located at 5991 S Sunbury Road, Westerville, OH. The time reviewed was prior to when the Officer-Involved Critical Incident occurred. SA Poole received a copy of the video files located on a CD disk. The footage is saved within the physical case file. Please review the video footage in its entirety for specific details.

SA Poole reviewed the video and the following time line was noted within the surveillance video.

- At 18:21:51 on camera L4 Ta'kiya Young (Ta'kiya) was seen entering the liquor store.
- At 18:23:01 on camera L1 Ta'kiya is seen pulling a large bag from her purse.
- Starting at 18:23:13 and ending at 18:24:28 on camera L1 Ta'kiya is seen taking seven (7) different bottles from the shelf and placing it in her large bag.
- At 18:24:36 on camera L4 a female Black dressed in a black shirt, closely resembling Tanyla Young (Tanyla) (Suspect #2) enters the liquor store.
- At 18:24:44 on camera L4 an unknown female Black with a hat and nose ring (Suspect #3) enters the liquor store.
- Between 18:24:44 and 18:24:09 on camera L5 Ta'kiya is seen concealing three (3) more liquor bottles into her purse.
- Between 18:25:40 and 18:26:11 on camera L5 and L1 Suspect #2 is seen taking one (1) bottle of liquor from the shelf and concealing it in her purse and takes another bottle of liquor and holds it in her hands.
- Between 18:25:39 and 18:27:00 on camera L5 and L1 Suspect #3 is seen concealing three (3) bottles of liquor in her purse.
- At 18:25:43 on camera L2 Ta'kiya is seen placing another liquor bottle in her shopping basket.
- At 18:27:14 on camera L4 Ta'kiya, Suspect #2 and Suspect #3 are seen exiting the Liquor store triggering the EAS alarm system. Ta'kiya is seen with her large bag, purse, and shopping basket that still has bottles inside it.
