Narrative:

On Friday, September 20, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Aja Chung (SA Chung) received requested records and recordings from Fairfield County Sheriff's Office (FCSO) Detective Jason Meadows. SA Chung had previously requested all dispatch records, audio recordings (radio, 911, and phone), and any other dispatch/communications-related information. All files were saved electronically to the BCI shared folder.

On September 7, 2024, Chad Evangelista (Evangelista) was arrested for disorderly conduct and obstructing official business by the FCSO and transported to the Fairfield County Jail.

- 1:30: Unit [REDACTED] airs there is another deputy on scene.
- 1:32: Madison 13 radioed to dispatch two units are enroute.
- 1:37: An unknown police unit requests unit [REDACTED] location.
- 1:38: Radio dispatch airs unit [REDACTED] location.
- 1:40: Radio acknowledges Madison units 13 and 15 are enroute.
- 1:48: Lithopolis 8 and Lithopolis 1 air on scene.
- 1:54: Radio dispatch tells unit [REDACTED] what other units are enroute and asks if unit [REDACTED] need units 529 and 530 to continue to the scene.
- 2:10: Lithopolis 1 airs: "He's detained."
- 2:15: Unit 530 airs himself and unit 529 are still responding to the scene, non-emergent.
- 2:19: Unit [REDACTED] stated no other units are needed and that the subject is detained in the back of a Franklin County Sheriff's Office cruiser.
- 2:28: Madison units air on scene.
- The recording ended.

911 Calls:

SA Chung received three (3) 911 call recordings that consisted of one (1) citizen caller that called twice, and two 911 calls from Evangelista that were transferred from the Franklin County dispatch center.

The following was noted in folder: waterloo_A:

- A female caller, later identified as Tammy Workman (Workman), tells Fairfield dispatchers a male is walking in and out of the road. She described Evangelista's actions as walking in one little area. She described Evangelista walking as, he would take a few steps, turn around, take a couple steps and turn around.
- Workman provides a clothing description of black and white shoes, a black shirt, sunglasses on his head, and a phone in his hand as if he were using it.
- 1:40 minutes into the recording, Workman called again stating there is an agitated male in front of Aldi's. Workman further said, "He doesn't seem right or normal." Workman advised she has watched Evangelista for a few minutes and described him as a W/M, heavier set, dark jacket on, shorter haircut, wearing shorts.
- The recording ended.

The following was noted in folder: waterloo_B. The recording was 2:38 minutes long and was a 911 call transfer from Franklin County Dispatch center.

- A male was heard screaming "Help!", "Help me!" and "Someone help me!" multiple times.
- Another male voice can be heard, faintly, saying, "Get on the ground!"
- The female dispatcher asked the caller his location.
- The male was heard saying, "I'm at the..." two times but never completed the sentence.
- The female dispatcher recognized the caller as Evangelista, the same subject the Fairfield Sheriff's deputy was out with. She further advised Evangelista to comply with the unit.
- The male caller/Evangelista was heard still yelling, "Help!", "Help me!", "Ahhh!", "Mom!" repeatedly.
- Franklin County dispatchers could be heard saying, "I can hear the unit in the background (inaudible)."
- 0:50 seconds into the recording, Fairfield dispatch requests Franklin dispatch to send Madison Township units to the area.
- As the Fairfield dispatcher keeps an open line, Evangelista was heard continually screaming for help.
- At the 1:29 minute mark, the unit/deputy was heard saying, "Chad, stop! On your knees, now!"
- The call disconnected at the 2:30 minute mark.

The following was noted in the folder labeled: waterloo_C. The recording was a 911 transfer call from the Franklin County dispatch center and was 2:44 long.

- The recording began with a male yelling in the background. The male was heard yelling, "Help!"
- Dispatchers trade information regarding the deputy out with a male subject who is being uncooperative and fighting with a Fairfield County deputy.

- Fairfield dispatch confirms Franklin County dispatch has requested a Madison Township unit be enroute.
- Fairfield dispatch remains on the line and tells Evangelista to comply with the unit. Evangelista can still be heard yelling, "Stop!", "Someone help me!", "Ah!", "Mom!" multiple times.
- The Fairfield deputy can be heard saying, "Quit!", "Stop!" and "Relax." The Fairfield deputy can be heard airing over the radio, "Bob Evans" as police sirens are faintly heard in the background.
- 1:59 minutes into the recording, Fairfield dispatch advised Franklin County dispatch Evangelista was detained.
- Evangelista can still be heard yelling his name amongst other things in the background.
- The call disconnected at the 2:39 minute mark.
