Narrative:

On Monday, June 30, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chad Holcomb (SA Holcomb) received requested records and recordings from Columbus Division of Police (CPD) Sgt. Terry McConnell. SA Holomb had previously requested all dispatch records, audio recordings (radio, 911, and phone), mobile data terminal (MDT) communications, and any other dispatch/communications-related information for the following date May 19, 2025. As a result of that request, the following items were received and reviewed:

Computer Aided Dispatch (CAD) Records:

- Caller from 4484 Hampton Woods Court calls in saying there is a domestic next door.
