Narrative:

On [REDACTED], Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jesse Bynum (Bynum) and the Medina County Prosecutor's Office presented the September 18, 2025, officer involved critical incident to a Grand Jury in the Medina County Court of Common Pleas.

The Grand Jury issued a decision after the case was presented that the use of force was justified and declined to file criminal charges regarding the actions of Brunswick Division of Police [REDACTED] (S), [REDACTED] (S), [REDACTED] (S), [REDACTED] (S), and Brunswick Hills Township [REDACTED] (S). On the same day, SA Bynum received an email from the Medina County Prosecutor's Office with a letter stating that the Grand Jury declined to file charges. That letter is attached to this report.
