Narrative:

On Tuesday, November 26, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jesse Bynum (SA Bynum) received vehicle data recovered by Medina County Sheriff's Office (MCSO) Detective Sergeant Larry Covey (Covey) on November 18, 2024.

SA Bynum reviewed the data and noted the following:

The Ford F-150 driven by Charles Alexander on November 11, 2024, was impounded and on November 18, 2024, Detective Sergeant Covey utilized Berla equipment to extract data from the vehicle's infotainment system.

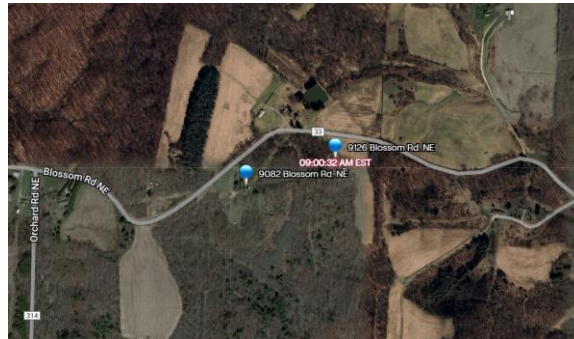

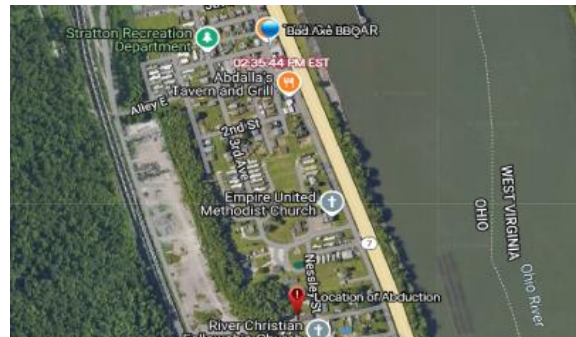

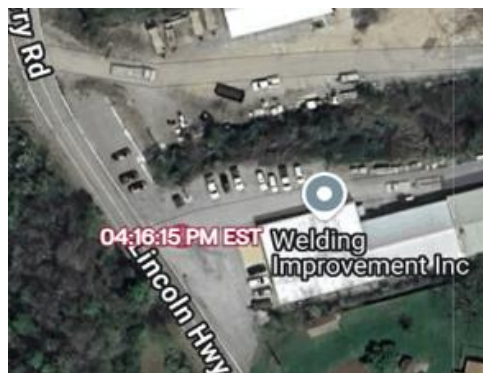

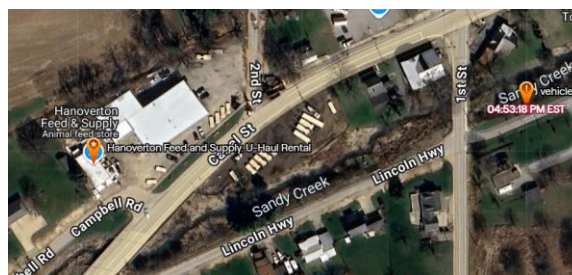
