On June 28, 2024, Special Agent James Poole (SA Poole) reviewed the Cruiser Dash Cameras of the involved officers in the incident that occurred on April 19, 2024, involving an Officer-Involved Critical Incident (OICI) in the parking lot of 4632 East Main St, Whitehall OH.	
The incident involved two Whitehall (WPD) Police Officers and individuals identified as William Villatoro (Villatoro) and now deceased Santiago AlfaroMunoz (Alfaro Muñoz). - As approaches the driver side door Villatoro is still reaching over his right shoulder to the back seat and suddenly moves forward back into his seat after seeing approach.
- At the 11:08 minute mark is seen arriving and parking his cruiser in front, facing the driver's front side with his headlights.


- At the 11:19 minute mark approaches the passenger side of the silver Honda Pilot and begins conversing with the passenger, later identified as Alfaromunoz.
- At the 11:27 minute mark reaches into the passenger side window and is handed a can in which he then begins to pour out onto the parking lot.
- At the 11:40 minute mark is seen looking through the rear driver's side window with his flashlight and suddenly moves back to the driver side trying to get s attention.
- At the 11: 55 minute mark opens the driver side door and places Villatoro in handcuffs without incident.



- At the 12:12 minute mark open is seen opening the passenger side door open.
- At the 12:13 minute mark Alfaromunoz is seen quickly reaching over his left shoulder to the back seat of the vehicle while takes step back drawing his duty weapon towards Alfaromunoz.



• At the 12:14 minute mark seem taking another step backward and firing one round towards Alfaromunoz.



• At the 12:15 minute mark is seen firing several rounds towards Alfaromunoz while taking steps backwards away from the vehicle.



- After the shots stopped can be heard screaming Manos Arriba = Hands up!
- Between minute marker 12:20 and 15:12 Alfaromunoz can bee seen moving around in the passenger seat.
- At the 15:12 minute mark five (5) WPD officers with a shield and riffle approach the passenger side door.
- Three (3) officers then move to the driver side to start giving Alfaromunoz life saving aid.
- At the 18:20 minute mark medics arrive on scene.
- Officers are seen setting up scene security. scene tape, and moving cruisers out of the way for medics.
- At the 20:55 minute mark Medics move Alfaromunoz onto a stretcher while an officer moves the cruiser where it is blocked by a brick wall for the duration of the video.
