#### Narrative:

On the morning of September 10, 2024, an Officer-Involved Critical Incident took place in the rear parking lot of the Columbus Division of Police (CPD) Precinct 4 Substation. Six officers engaged an armed subject, Lamine Mahmoudi, who was mortally wounded. The involved officers were (in no particular order):



On October 15, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) James Gore received copies of firearms qualifications records for the involved officers from CPD Sergeant Terry McConnell. The records confirmed that all of the officers qualified with their Division issued handguns (Smith & Wesson M&P 2.0 9mm) in March, 2024.

Copies of the firearms qualification records are available for further review as attachments to this report.
