Narrative:

On Monday, July 21, 2025, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman received Middletown Police [REDACTED] training records from Deputy Chief Ryan Morgan. SA Seitzman reviewed the records and noted the following:

Range Qualification Records:

[REDACTED] successfully qualified with an HM Defense Raider MC .556 patrol rifle on April 16, 2025, receiving a perfect score. On the same date, he successfully qualified with a Glock 17 duty pistol, also receiving a perfect score.

Subject Control Training

[REDACTED] training records indicate that he has completed various subject control training sessions. Specifically, he received training in the use of the TASER, ASP baton, and OC spray. He has also completed training in high-threat close quarters combat and basic SWAT.
