On Wednesday, December 11, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joe Lamping (SA Lamping) received a copy of the Trumbull County Sheriff's Office (TCSO) crime scene log from Major Douglas Bobovnyik.
