Narrative:

On May 20, 2025, several officers with the Columbus Division of Police (CPD) responded to 4482 Hampton Woods Court, Columbus, Ohio, to a shooting complaint which ultimately resulted in an Officer Involved Critical Incident (OICI).

As a part of the BCI's investigation into the above incident, CPD provided BCI with a large volume of body worn camera (BWC) video footage associated with officers responding to the incident. BCI Special Agent Lauren Frazier was assigned to review a portion of the referenced video footage. SA Frazier was assigned to review 12 videos uploaded by five officers who responded to the incident.
