Narrative:

Throughout the investigation, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman received body-worn and cruiser camera footage from various agencies that assisted the Evendale and Lockland Police Departments during the search for suspects related to the involved vehicle pursuit and subsequent officer-involved critical incident.

SA Seitzman confirmed that none of the videos, with the exception of Hamilton County Sheriff's Office Corporal Shane Wiseman's, captured the shooting event. Cpl. Wiseman's bodyworn camera footage was detailed in a separate investigative report.

SA Seitzman reviewed each video to the extent necessary to determine potential relevance. The videos were not reviewed in their entirety.

SA Seitzman reviewed the videos and noted the following:

Evendale Police Department Body-Worn Camera Footage:

All videos submitted by Evendale were reviewed. Nothing noteworthy was discovered. The videos either ended prior to the officer-involved critical incident or occurred afterward.

Hamilton County Sheriff's Office:

All videos submitted by the Hamilton County Sheriff's Office were reviewed. The only relevant footage was from Axon Body 3 Video 2025-03-19 0311 X60A9834N, where the deputy passed Lockland Police as he was surrounded by other officers instructing him to get into a cruiser. The deputy then assisted with medical aid efforts.

Sharonville Police Department:

SA Seitzman reviewed each video submitted by the Sharonville Police Department and identified four videos of potential relevance. *Axon Body 3 Video 2025–03–19 0311 X60AC7843* captured the Sharonville officer walking past who was leaning over a guardrail and appeared distraught.

Axon Body 3 Video 2025-03-19 0310 X60AA0154 showed another Sharonville officer arriving at the scene. The officer walked past who had his hands on top of his head and appeared distraught. Could be heard yelling, "Fuck!" The Sharonville officer proceeded to the scene and assisted with providing medical aid.

Axon Fleet 3 Front Camera Video 2025-03-19 0246 appeared to capture footage from a stationary Sharonville police cruiser on Evendale Drive near Glendale Milford Road. At 03:11:22, according to the timestamp, five distinct gunshots can be heard in the distance.

Axon Fleet 3 Front Camera Video 2025-03-19 0231 and (Overlay 1) Axon Fleet 3 Front Camera Video 2025-03-19 0231 appeared to be the same video. The video showed a Sharonville police officer briefly pursuing the involved vehicle. The pursuit lasted less than a minute. The officer continued to briefly follow the vehicle. The footage was terminated prior to the shots being fired.

Wyoming Police Department:

SA Seitzman reviewed each video submitted by the Wyoming Police Department. Each video was titled I–75 OIS. For the purposes of this review, SA Seitzman added the associated metadata from the relevant videos for identification. *175 OIS Uploaded by Tom Riggs– BWC–Mar 19, 2025 3:13:40 AM*, showed a Wyoming police officer arriving after the shots were fired. As the officer approached the scene, **Sector** could seen surrounded by other police officers near a police cruiser.

175 OIS Uploaded by Jordan Batts- BWC- Mar 19, 2025 3:12:44 AM, Wyoming Police Officer Jordan Batts arrived after the shots were fired. Officer Batts walked with **Constant of Sector Police** and Lockland Police **Constant of Sector Police** The officers walked to a Lockland police cruiser, at which point Officer Batts told **Constant of Sector Police** asked for his phone to call his **Constant of Sector Police** and them to **Constant of Sector Police** Batts again instructed **Constant of Sector Police** and handed them to **Constant of Police** Batts again instructed **Constant of Sector Police** and handed the incident with anyone until he spoke with an attorney.

I-75 OIS- Uploaded by Ryon Warmack- Mar 19, 2025 3:10:53 AM BWC, showed Wyoming police officer Ryon Warmack arriving after the shots had been fired. Officer Warmack ran past and told him to sit down. Officer Warmack then assisted with providing medical aid. He cut and removed the involved subject's clothing to assess for injuries. He aided officers with applying a chest seal, as well as a tourniquet around the involved subject's left leg.

All videos were labeled and stored on Axon Evidence.com under case ID 2025-0883. Each agencies videos were organized in folders.

Cincinnati Police Department:

On April 8, 2025, BCI SA Hornyak received video footage from the Cincinnati Police Department pursuant to a records request. SA Seitzman downloaded the footage, which consisted of 64 video files, 64 audit logs, and a table of contents.

CPD250319000138-37082-3_19_2025_3_12_52_AM-2 showed Cincinnati Police Officer Vanessa Stewart arriving at approximately 0315 hours, according to the timestamp. She walked toward the involved subject while donning medical gloves. She then took over chest compressions from another officer. Another officer took over chest compressions at approximately 0319, according to the timestamp. Paramedics could be seen arriving to the involved subject at approximately 0319 hours, according to the timestamp. Officer Stewart did not appear to have any further involvement at the scene.

CPD250319000138-37099-3_19_2025_3_12_52_AM-3 showed Cincinnati Police Officer Justin Shields arriving with Officer Stewart. Officer Shields did not have any involvement at that time.

CPD250319000138-37099-3_19_2025_3_12_52_AM-2 captured Officer Shields dealing with two male bystanders in the vicinity of the crime scene. The subjects got into a vehicle that were stopped on the highway. The subjects were generally argumentative with Officer Shields and left the area by driving the wrong way on the the highway after the officer discouraged the conduct.
