Mr. Yost,

We have received a SP request from Cuyahoga County for a fatal OICI/OIS:

Agency: Cleveland Metropolitan Housing Authority

Officers: Ofc. [REDACTED] and Sgt. [REDACTED]

Deceased: Demond Eskridge age 42

Investigating Agency: Cleveland PD

Location: 3498 East 98<sup>th</sup> Street Cleveland

Officers were responding to a report that a man (Eskridge) was throwing objects (a bed frame, a door, chairs) from the seventh floor balcony of the Union Square Housing Complex. Officers struggled with Eskridge on scene and Eskridge reportedly bit an officers finger off. Officers fired at least one shot, striking Eskridge. Eskridge was taken to a hospital and pronounced dead shortly thereafter.
