### Initial Narrative By Taylor Jackson, 02/17/25 18:00

On 02-17-25 I responded to a burglary complaint in the area of Pleasant Valley Rd. Investigative Notes Narrative By Taylor Jackson, 02/17/25 18:02

On 02-17-25 I, Deputy Jackson, and Deputy Sams responded to a burglary complaint at 15329 Pleasant Valley Rd. Upon arrival in the area myself and Deputy Sams responded to the residential address of the caller (Haley

Woods). Upon arrival at the above address we met with Haley in her driveway. Haley stated she would not enter the residence unit she knew it was safe. Myself and Deputy Sams then entered and cleared the residence. Once the residence was cleared and we had negative contact inside the home we returned back outside to Haley and asked her to join us inside. Upon entry, Haley stated that she had seen the suspect exit her bedroom from behind the door. When asked what had happened from the time of her return home Haley stated that she entered through the back door and had walked into her living room to turn on her heat. Haley then stated that when she turned around she noticed water marks on her floor that were not from her dog. Haley stated that she walked into the dining room area of the residence and at that time noticed her personal handgun missing along with the loaded magazine beside it. Haley was asked where the handgun had been left to which she stated she left it on the small table in the dining room, unloaded, and a loaded magazine with (6) bullets inside beside the handgun. Haley stated that at this time she saw the male suspect exit her bedroom and face her with her personal handgun pointed at her. Haley stated that all the suspect said at that time was "Give me money".

Haley stated that at that moment she left the residence and the male suspect followed her. Haley stated that she ran across Pleasant Valley Rd to a neighboring residence and the male suspect returned inside. At this time Haley was on the phone with Ross County Dispatch and watched the male suspect enter her residence again before exiting and running across SR-104 to the church. Haley stated that while watching the incident from beside the neighboring residence she witnessed a Ross County unit arrive on scene at the church. Haley then stated that she witnessed the male suspect point the handgun at the Ross County Unit followed by the Ross County Unit getting behind their cruiser and brandish their firearm as well. Haley stated that she then watched the suspect drop to the ground.

While Haley was talking with Deputy Sams, I went outside and began taking photographs. I noticed while inside there was plastic covering the windows in the living room. The plastic that was covering the right front window appeared to have been tampered with due to it not being flush against the window like the others. While outside photographing the window I noticed that the window appeared to be unlocked along with misc coins scattered under the window. Once I returned inside to take more photographs I asked Haley if the coins had been there previously to which she denied.

Haley was then given a statement form before being interviewed by a detective. This matter is being turned over to the Detective Unit at this time for further investigation. Investigative Notes Narrative By Kevin Pierce, 02/17/25 20:49 Case follow up

I was dispatched to 15329 Pleasant Valley Rd in reference to a Burglary. I arrived and made contact with Deputy Sams, who stated that the home owner came home and there was a male in the home.

I made contact with the home owner, Haley Woods who started to give a written statement, however I requested a taped statement. Haley advised that she got home today at approx 15:30 from work, and that when she went into the home she then took her dog out side and walked him around. Haley stated that when she came back into the home she always uses the rear door of the home. Haley advised that she then entered the kitchen area, and walked into the dinning room. Haley advised that she noticed her 9mm pistol sitting on her table in the dinning room. Haley advised that she noticed her 9mm pistol sitting on her table in the dinning room. Haley advised that she did not put it there and was walking back out of the home. Haley stated that when she got to the rear door and just opened it, a male came from her bedroom area and pointed a gun at her and stated "give me some money". Haley advised that she and her dog then ran out of the back door and around the house. Haley stated that she had ran out of her shoes, and that she and her dog went to the west side of the road. Haley advised that she and her dog did hide behind a vehicle, and she called (911). Haley advised that while she was on the phone with the 911 operator, she did see the male run from the rear of her home and across St Rt 104. Haley stated that the male ran toward the Chillicothe Baptist Church, that's when she saw a deputy make contact with male. Haley stated that the male had on a camouflage jacket, black hoodie, and black pants. At this time, Haley stated that she did see the male point a gun at the deputy, and that the deputy then got behind his marked patrol vehicle. I did ask Haley if she saw or heard any gun shots, and she stated that she did not. Haley advised that she just saw the male fall to the ground.

Haley advised that the male looked to be over 5 foot 8inches tall, and his face had a lot of acne scars, and looked like he had several layers of clothing on. Haley stated that she could not advise if anything else was missing from the

home other than her 9mm pistol.

I did take photos of the home, and was able to determine that entry was gained through the front of the home, threw a window. The front window was still opened, and the plastic was removed from it. There was misc coins on the front porch at the window where the male broke into the home. These coins was collected by me, and secured into evidence. After the photos were taken, and the taped interview was completed, Haley was able to check her jewelry box that was sitting on top of her dresser, and could not advise if there was anything missing. I was then contacted by Capt Addy and asked about several rings that were by the male. Haley looked at the photos that he had sent to my phone, and stated that she could not say for sure. Haley advised that the rings that are missing were not expensive, but could not say for sure that they were hers.

I did advise Haley that agents from BCI&I would be in contact with her in reference to the burglary, to conduct a follow up to this report.

## Investigative Notes Narrative By Heather Crosier, 02/18/25 11:06

#### Suspect identification/care and scene processing

I responded to 14000 SR 104, Chillicothe, Ross County, upon being notified by Captain Adair of the incident. On scene, I met with Captain Adair before continuing to the Adena Health Systems Emergency Department. There, I collected four bags of evidence from Sergeant Champion and Deputy Van Gundy. Those items included two pair of pants, a pair of black boots, and a magazine with an unknown number of unknown type/caliber rounds in it. In the ED, the items were placed into evidence bags and immediately moved by myself and Deputy Van Gundy to be secured in my vehicle. No photographs were taken of the items; they were not removed from the bags. The bags were surrendered to BCI Crime Scene Special Agent Brittany VanBibber at approximately 2130 hours on 02/17/2025.

While at the ED, the subject's identity was not immediately known. Photographs of the subject's face and tattoos were provided to law enforcement and through that, the subject was identified as being Daniel W Long. Any photos taken of Daniel Long at the ED are uploaded to this report.

I remained at the ED with Ross County Coroner's Office Investigator Scott LaGard and the body until the body was released to Haller's Funeral Home for transport to Montgomery County Coroner's Office for an autopsy.

Once BCI was finished processing the scene at 14000 SR 104, Deputy Nott and myself collected the remaining belongings deemed unnecessary for BCI's investigation. Those items included lighters, a phone charger, a vape, ear buds, Lowe's gift card, rolling papers, two padlock-style keys with a soda machine style key on a keyring, a syringe, a pink pill which disintegrated in packaging (a second pink pill was on scene disintegrating), two rings and a heart pendant, and coins. The items were placed into evidence.

On 2/17/2025, I was dispatched to 15329 Pleasant Valley Rd in reference to a burglary. While en-route to the call dispatch advised that the male had left the scene and was wearing a camo jacket. **Second and Ramsey** had marked dispatch stating that they were close by and would head that way as well. They both advised that they did not have their body worn cameras as they were coming on shift and were heading to the patrol building to obtain them. **Second advised** that he observed a person matching the description walking in the driveway to the Chillicothe baptist Church located at 14000 ST Rt 104. I then heard **Second advised** that he had the subject at gun point. I

then heard mark back up and state that shots were fired. I then arrived on scene and parked my marked patrol vehicle with the emergency lights on in the north bound lanes of ST Rt 104. I grabbed the medical kit out of my patrol vehicle and ran up to the scene where and Ramsey were. I observed the suspect laying on the his back with his jacket open as and Ramsey were starting to render aid. I then pulled away from the scene and tossed my medical kit to Deputy Ramsey and Deputy Nott and advised them to render aid and start CPR if necessary. I then walked with taking his service sidearm and placing it into to take his vest off as I needed to check him for any injuries. I checked my patrol vehicle. I then advised him for injuries and did not observe any. I then deactivated my body worn camera and assumed them role as Union I made contact with Lt. Hollis and gave her possession of representation for sidearm. I then cleared the scene with and took him to the Law Enforcement Complex. On 2/17/25 at approximately 4:52 pm Dispatch advised that there was an active burglary taking place at 15329 Pleasant Valley Rd. Dispatch advised that the caller, Haley Woods, stated that a man had broken into her residence. Dispatch advised that Haley stated the male had a gun and was wearing a camo jacket and brown and black pants and that he was walking across SR-104.

Deputy Tatman and Deputy Nott advised that they would be en route to the scene. Who was not on duty at that time but was en route to the RCSO Patrol Headquarters to begin his shift at 5:00 pm, advised that he was close to that location and that he would respond to the scene as well. Who was advised that he did not have his body camera with him. It is a common practice for RCSO Patrol Deputies who are responding to a call for service before the start of their scheduled shift, who do not have their body camera due to not having retrieved it from Patrol Headquarters yet, to advise over the radio that they do not have their body camera.

Shortly after advising that he would be responding, **and the second advised that he was on scene and had located the suspect near the church on SR-104 near US-35.** Once on scene, **advised that he was on scene and had located the and then "shots fired", and then "suspect down". At that point Dep. VanGundy and I, who were at Patrol Headquarters located at 4447 SR-159, began responding to the scene in my cruiser with the emergency lights and siren activated. While en route I called Lt. Hollis to advise her of the situation, however she was already aware and advised that she was responding to the scene as well.** 

Dep. Ramsey, who was also on his way into work and was not yet on duty, advised that he would be responding to the scene and did not have his body camera with him. Deputies Nott, Ramsey, and Tatman arrived on scene and shortly thereafter Dep. Ramsey advised "CPR in progress".

Dep. VanGundy and I arrived on scene at 5:00 pm. When I exited my cruiser I observed Dep. Tatman and Dep. walking toward Dep. Tatman's cruiser. Dep. Tatman was carrying **served scenes** s department-issued Sig

Dep. VanGundy grabbed my medical bag and we ran to Dep. Nott and Dep. Ramsey, who were rendering aid and performing CPR on a male subject. The male was unconscious and was laying on his back wearing a camo jacket, along with a hoodie and and at least one t-shirt. The male's hood was up over the top of his head. I located a small hole with a small amount of blood around the rim on the front of the male's sweatshirt near the left nipple area. I then donned nitrile gloves and used a pair of medical scissors to cut through the male's shirts to make his injury accessible. While I was cutting the male's shirts, Dep. Ramsey asked me what he should do with the gun. Because medical aid was being rendered by Dep. Nott, Dep. VanGundy, and I at that time, I knew it was only now necessary to become concerned with scene/evidence preservation. Knowing that the scene was about to become even more chaotic with numerous EMS and RCSO Deputies arriving, I instructed Dep. Ramsey to secure the gun in his cruiser for the time being so that we could maintain a clear chain of custody.

Once the male's shirt was cut away and his bare chest was revealed, I observed a small circular wound on his left pectoral muscle above his left nipple. The wound was consistent with that of a 9mm bullet having entered into a human body. The wound had a small amount of blood around it, but it was not bleeding excessively. Because of this I determined that it was more important to seal the wound with a chest seal in case the male's plural cavity had been penetrated by the bullet. I finished applying the chest seal as EMS arrived on scene. An EMS member and I then rolled the male subject onto his right side so we could check for any exit wounds. I did not observe any wounds consistent with a bullet exiting the human body on the back of the male's torso. I also did not observe any wounds consistent with a bullet entering the human body on the rear of the male's torso. The male had been secured in handcuffs behind his back by Dep. Ramsey prior to my arrival on scene. At this point I removed the handcuffs from the male and secured them on my person. I assisted EMS in securing the male into the Lucas machine, which provided automated chest compressions to the male. At no time did I check the male for a pulse and instead I focused on providing life-saving aid.

I then tasked Deputy VanGundy with writing down the identities (name and date of birth) of the EMS members on scene. EMS loaded the male into the back of an ambulance and transported him to the Adena Regional Medical Center (ARMC). Deputy VanGundy rode in the back of the ambulance and I followed them to the hospital in my cruiser. Upon arrival at the hospital we met with Det. Sqt. Crosier and we stood by in the trauma room and witnessed ARMC staff perform medical treatment on the male. During this time ARMC staff located a black handgun magazine in the front left pocket of the male's pants. I observed that there were bullets in the magazine. ARMC staff provided evidence bags and Det. Crosier and I then worked to secure all of the male's clothing, except for his underwear, and the handgun magazine into the evidence bags. We left the underwear on the male. I stayed in the trauma room while Dep. VanGundy and Det. Crosier secured the evidence bags.

At 5:39 pm ARMC staff stopped performing life-saving measures and determined that the male had died and all further resuscitation efforts were futile. Dep. VanGundy and I remained on scene until Ross County Coroner Investigator Scottie LaGard arrived on scene. During this time Det. Crosier, with the help of other detectives she was communicating with over the phone, was able to tentatively identify the male subject as Daniel Long (DOB: 4/6/85) based off of his numerous tattoos. Dep. VanGundy and I cleared the scene. I submitted Dep. Ramsey's handcuffs into the evidence lockers in the event that they were needed for the investigation.

#### I recorded the incident on my body camera, which was activated at approximately the same time I arrived on scene. Investigative Notes Narrative By Bryan VanGundy, 02/21/25 16:50

On 2/17/25 at approximately 4:52 pm Dispatch advised that there was an active burglary taking place at 15329 Pleasant Valley Rd. Dispatch advised that the caller, Haley Woods stated that a man had broke into her residence and had stolen her gun and was wearing a camo jacket and black pants and that he was walking across SR-104.

Deputy Tatman and Deputy Nott advised that they would be en route to the scene. was not on duty at that time but was en route to the RCSO Patrol Headquarters to start his shift at he advised that he was close to that location and that he would respond. advised dispatch that he did not have his body camera on, because he had no made it to RCSO Headquarters yet.

advised dispatch that he saw the subject near the church on SR-104. Then I heard advised dispatch that he had one at gun point, and then advised shots fired. At this point Sgt. Champion and I responded to the scene in his cruiser with the overhead lights and siren on. As we arrived on scene there was one cruiser in the northbound lane of SR-104 just before the driveway to the church. Sgt. Champion stopped his cruiser just north of the driveway in the northbound lane. I saw Deputy Tatman walking with and he had and he had and he had advised sig P230 9mm firearm in his hand. Sgt. Champion told me to grab his medical bag and follow him. We ran to the scene where Deputy Nott and Deputy Ramsey were conducting CPR to who was later identified as Daniel Long.

Sgt. Champion opened his shirt to locate the gunshot wound. We located the entrance wound on the upper left pectoral muscle. We rolled him onto his right side to try and locate an exit wound and did not see any exit wound. As we rolled him back over Sgt. Champion applied a chest seal to the area with the entrance wound. Deputy Nott was doing chest compressions and was getting tired. Sgt. Champion advised me to take over for Deputy Nott so I took over chest compressions and continued until the Medics arrived and applied the Lucas device.

I then started to help Sgt. Champion in cutting off Daniels hoodies and shirt. The Medics had the Lucas device in place and we had removed his shirt and hoodies. At this time I got all the Medics and EMT's information. And they are as follows: Nick Sheerin 11/23/93, Trevor Sickels 04/24/94, Chief Grim 01/27/71, Ashley Thacker 07/31/86, Carlos Chafin 10/31/97, Jessica Carnal 12/20/84, Bryanna Sickels 05/20/94, Russel Aikman 06/08/81, and Alexander Stewart 05/28/02.

I then rode in the ambulance with Daniel to the hospital as the medical personnel continued using the Lucas device, checking his pulse, and getting IV's started. Once we arrived at the hospital we went into the surgery room were a magazine was found in his left front pocket. Sgt. Champion, Detective Crosier, and myself put his clothing, except for his underwear, and the magazine into evidence bags. Myself and Detective Crosier secured the evidence bags in her truck. I went back into the hospital and watched as the hospital personnel continued to try to save his life. At 0539 they pronounce the time of death. Detectives worked to find out the identity through pictures of his tattoos. They identified him as Daniel Long as the Coroner arrived.

Sgt. Champion and I released him to the coroner and made our way back to the Law Enforcement Headquarters.

# Investigative Notes Narrative By Ryker Nott, 02/21/25 17:36

On 2/17/2025 I, Deputy Nott, was dispatched to 15329 Pleasant Valley Rd for an active burglary. Before arrival I was also advised that the suspect did have a firearm on him. I was also advised that the suspect was walking away from the residence across State Route 104. I then heard over the radio that **State Route** and Deputy Ramsey were en route and were a lot closer. They both advised they did not have their body worn camera's as they were on their way to work.

While en route advised he had the subject at gun point and then shortly after he advised "shots fired" and called for an ambulance for the subject who was down. I then arrived shortly after and blocked the entrance with Deputy Tatman arriving at the same time. I ran up and observed Daniel laying on the ground unconscious. I then went and began life saving measures and advised Dispatch that I began CPR. While conducting CPR I discovered one bullet hole on the left side of Daniel's chest. At this time I switched CPR with Deputy Ramsey and I began to search Daniel for anymore weapons on his person. I discovered several rings in his pocket and other miscellaneous items but no weapons in his immediate pockets.

Shortly after Sgt. Champion and Deputy VanGundy arrived and as I started CPR again, Deputy Ramsey cut Daniel's shirt off and Sgt. Champion placed a chest seal on Daniel's bullet wound on his chest. We looked but were unable to find a exit wound in Daniel's back. At this time Union Township EMS arrived and took over CPR on Daniel. I then was advised to go get the firearm and place it in an evidence bag and give it to Captain Adair. I then proceeded to Deputy Ramsey's vehicle where he had taken the gun after he took it away from Daniel. I then placed the firearm in a brown paper bag and handed it to Captain Adair.

After this I proceeded to 15329 Pleasant Valley Rd to speak with the victim, Haley Woods, Upon arrival I discovered that Deputy Jackson and Deputy Sams had already spoke with the victim. I did however discover that the firearm that

Daniel had was taken from the residence and is registered to Haley. I then went to the neighbors house as I was told she might have heard someone at her door around the same time. I made contact and had her fill out a voluntary statement for detectives. I then proceeded back to the scene at the Chillicothe Baptist Church and I stayed at the scene until BCI agents arrived and did their investigation. I then waited for everyone to leave the scene before clearing.

#### Investigative Notes Narrative By Jacob Riege, 02/21/25 18:48

On 02/17/2025 at approximately 1641 hrs, I, Sgt Riege, was traveling on US 50 near Jones Rd to station to start my shift when I was advised of a structure fire near my location. I started in the direction of the fire to assist the Fire Department. While enroute to the fire, Dispatch had advised of an active burglary occurring on Pleasant Valley Rd and a firearm being involved. Multiple deputies advised that they were enroute to include who advised that he was close to the area already. I was at SR 327 and Vigo Rd when when the subject was down. I observed the Fire Department in front of me on SR 327 and decided to divert to **Exercise** s location.

Upon arrival to the area of SR 104 from US 35, I observed multiple patrol vehicles and an ambulance just inside a church drive entrance. I parked my patrol vehicle with overhead lights activated, at the entrance to the church drive in the second lane of SR 104 to divert traffic away from the entrance. Upon approach to the scene, I observed Deputy Tatman with **Second** by **Second** s patrol vehicle. I also observed Sgt Champion Deputy Nott and Deputy Ramsey with EMS with the male subject. EMS was starting to load the male subject into the ambulance. I proceeded to assist in clearing a exit path for EMS. Also on scene was Sheriff Lavendar, Chief Hollis, Det. Capt. Adair and Lt. Hollis. I was instructed to secured the scene with Law Enforcement scene barrier tape upon the ambulance clearing the scene. I utilized traffic cones to block off the scene and tied the barrier tape from the nearby fence line to secured. I immediately exited my patrol cruiser and unholstered my department issued firearm and brandished my firearm at Daniel as well as I took cover behind my driver side door. I asked the stated was alright, to which he responded that he was and that Daniel had a firearm in his left hand. I explained to that I was going to approach toward Daniel to secure the scene.

As I approached Daniel, I noticed the firearm near Daniel's left hand. When I was able, I kicked the firearm near Daniel's left hand away from Daniel for safety precautions. **Security** and myself then proceeded to position Daniel onto his stomach and placed his hands behind his back for handcuffing. I then secured Daniel into handcuffs, which were checked for spacing and double locked, and Deputies then positioned Daniel onto his backside as Deputy Nott and Deputy Tatman arrived on scene. Deputy Tatman escorted **Secure** away from the scene as Deputy Nott began CPR on Daniel. I retrieved the firearm to secure it. I observed the firearm did not have an existing magazine inside of it and there was not a bullet in the chamber. I then placed the firearm back on the ground and began assisting Deputy Nott with CPR on Daniel where it was found that Daniel had what appeared to be a bullet

wound on the upper left chest region of Daniel. During CPR, Sergeant Champion and Deputy Vangundy arrived on scene with Sergeant Champion's medical bag. Sergeant Champion handed me a pair of medical shears to cut Daniel's sweatshirt and shirt for better medical observation. It was then confirmed Daniel had a bullet wound on his upper left chest region, but there was no exit wound located. Sergeant Champion proceeded to apply a chest seal on Daniel's bullet wound. EMS then arrived on scene to takeover medical treatment for Daniel.

I retrieved the firearm once more from the ground and secured the firearm inside of my patrol cruiser on the floorboard of the passenger front seat and secured my patrol cruiser for safekeeping. Captain Adair then advised he would take over chain of custody of the firearm. I retrieved a brown paper bag from the trunk of my patrol cruiser and had Deputy Nott retrieve the firearm from the passenger side floorboard of my patrol cruiser. Deputy Nott then placed the firearm inside of the brown paper bag. I then transfered the brown paper bag with the firearm inside to Captain Adair. At this time EMS then transported Daniel to Adena Regional Medical Center. I remained on perimeter of the scene until BCI arrived to conduct their investigation of the situation.

I then cleared the scene.
