**Narrative:**

On Tuesday, October 4, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) reviewed the personnel file, training and Ohio Peace Officer Training Academy (OPOTA) Polaris records for Westerville Police Department (WPD) Lieutenant (Lt.) [REDACTED] [REDACTED]. SA Tingley reviewed the provided documentation and noted the following:

**Personnel File**

Lt. [REDACTED] was hired by the WPD on September 3, 2002, as a full-time patrol officer. He had the following promotions: Corporal on December 4, 2019; Sergeant on January 13, 2020; and Lieutenant on April 3, 2022.

**Basic Training**

Lt. [REDACTED] attended and successfully completed the OPOTA Basic Training class PS86-578 at the Eastland Career Center from April 14, 1986, to June 19, 1986. Lt. [REDACTED] took and passed the OPOTA certification examination and was issued Peace Officer Certificate [REDACTED] by the Ohio Peace Officer Training Commission (OPOTC).

Lt. [REDACTED] attended and successfully completed a second OPOTA Training Academy Basic Training class BAS96-015 at the Ohio Law Enforcement Training Center from January 27, 1996, to May 8, 1996.
