Investigative Request

On the morning of Monday, December 26, 2022, at approximately 0945 hours, the Barberton Police Department requested the Ohio Bureau of Criminal Investigation (BCI) investigate a shooting involving a member of the Barberton Police Department. Specifically, the request was for an independent investigation into the facts and circumstances surrounding an officer-involved shooting which occurred in the area of 500 West Hopocan Avenue, Barberton, Ohio, and resulted in the death of Zachary Zoran. At approximately 1542 hours on December 26, 2022, Barberton Police Department Chief Vincent Morber confirmed the earlier request for assistance in writing via email. The BCI Crime Scene Unit (CSU) and the Special Investigations Unit (SIU) were requested and responded.

Preface:

Every fact and detail are not presented in this summary report. Therefore, it is recommended that each individual report from which this document is derived be read in order to obtain a complete understanding of this investigation. Further, audio and/or video recordings exist for the majority of the interviews conducted, revealing further details of statements given regarding the incident.

This investigation was conducted with the purpose of determining, to the extent possible, the facts and circumstances surrounding this incident. As unbiased collectors of fact, the investigative team has not and will not render any opinion of the legality of officer's actions. Instead, it is anticipated that this investigation will provide the basis of information for decisions to be rendered by the appropriate authorities.

Summary of Process

The following is a partial list of investigative activities or methods which were employed during the course of this investigation by the investigative team, in an effort to thoroughly and accurately locate and document all pertinent facts and circumstances regarding this incident:

- Video recorded interview of Barberton Police Officer [REDACTED] who discharged his weapon during the incident
- Video recorded interview of Barberton Police Officer [REDACTED] who was present at the scene of the incident
- Canvassed for and interviewed 12 witnesses to the incident
- Interviewed 6 additional people who interacted with the decedent in the days preceding his death
- Reviewed EMS records pertaining to their response and the medical treatment administered
- Canvassed for surveillance video cameras in the area surrounding the scene
- Reviewed all available surveillance video which captured any portion of the incident
- Obtained and reviewed body-worn camera video footage related to the incident
- Obtained and reviewed body-worn camera video footage of the subject on two prior occasions in the days leading up to this event
- Obtained and reviewed records of prior law enforcement contacts with the subject
- Obtained and reviewed open and closed-source biographical information on the involved subject, to include criminal history reports, OHLEG, driving records, etc.
- Processed the crime scene for potential evidence (photographing, searching, measuring, documenting and collecting)
- Reviewed audio communications on the radio frequencies utilized during the incident
- Reviewed dispatch/CAD records pertaining to the incident
- Reviewed Mobile Data Terminal (MDT) communications relative to the incident
- Issued preservation letters for social media accounts believed to have some relevance to the incident
- Reviewed Barberton Police Department's reports and investigative materials pertaining to the incident, (excluding any Garrity statements or information derived from any compelled statement)
- Conducted forensic laboratory examinations to include:
 1. Firearm identification testing of involved firearm and casing
 2. Firearm operability testing
 3. Taser operability testing

Incident Summary/Overview

On Saturday December 24, 2022, at approximately 0232 hours, Zachary Zoran (Zoran) called 911 and reported he believed an unknown person(s) had dug a large hole in a tree lawn across the street from him and buried human bodies in the hole. When police arrived, Zoran answered the door holding a baseball bat. Zoran went on the make additional statements and accusations to police during this encounter that appeared indicative of paranoia. During the commotion, Zoran's housemates came to the door and quickly dismissed his concerns to the responding police officers who left the home moments later.

Approximately 8 hours and 20 minutes later, at 1052 hours on December 24, 2022, Akron Police were again dispatched to the group home Zoran was residing at. This time officers were dispatched to the group home due to a complaint from the group home supervisor. The group home supervisor told police Zoran was acting erratic and threatening the other members of the group home. When officers entered the home, they encountered Zoran pacing in the kitchen and again holding a baseball bat. Zoran was asked multiple times to put the bat down. Zoran refused multiple commands to do so. Zoran had also just microwaved his iPad because he believed someone was using it to spy on him. Zoran, who had a knife on his person at the time, was eventually removed from the home against his will and taken to Akron General Hospital for a psychiatric evaluation.

Zoran was admitted to Akron General Hospital at 1215 hours. [REDACTED]

[REDACTED] Later that same day, after receiving medication and treatment, Zoran was released from the hospital.

Zoran returned to the group home and was told he would no longer be allowed to stay in the home by the home's manager. A group home supervisor ordered a Lyft (taxi-cab) for Zoran. Zoran was then taken to a duplex he had recently rented in Barberton, Ohio. During this same period of time, Zoran began sending threatening messages to multiple people and demanding his son be turned over to him. Zoran also began posting other nonsensical threats to his family and police on his public Facebook page around this time. A later search of the duplex Zoran rented noted carvings in the door, presumably made by Zoran, stating his son was being held in the attic.

The following morning, on Sunday, December 25, 2022, at approximately 0708 hours, Pamela Stratford (Stratford) reported to the Cuyahoga Falls Police Department that her son, Zoran, was sending her audio clips and text messages through Facebook messenger threatening to kill her.

Stratford reported that she felt concerned for her safety after receiving these messages. Stratford told the Cuyahoga Falls Police Department that Zoran had drug dependency issues and suffered from mental health problems. Based on Stratford's complaint, the Cuyahoga Falls Police Department obtained a warrant for the arrest of Zoran.

On Monday December 26, 2022, at approximately 0900 hours, Cuyahoga Falls Police created another police report in relation to more threats made by Zoran, now being sent to Sherry McCrossin (McCrossin). McCrossin reported that her nephew, Zoran, was sending her audio clips and text messages threatening to kill her and others if Zoran's son was not turned over to him. McCrossin stated she felt Zoran was likely under the influence of drugs and she feared he could potentially act on his threats in his current state.

At nearly the same time McCrossin was reporting the threats she received to the Cuyahoga Falls Police Department, Margaret Patterson (Patterson) called 911 and reported a man was following her and demanding her property. Patterson made her way into the Lake Anna YMCA, 500 West Hopocan Avenue, Barberton, Ohio, accompanied by an unrelated individual, Morgan Morrissey, whom Patterson located in the parking lot of the YMCA. Barberton police were dispatched to the Lake Anna YMCA regarding Patterson's complaint.

Barberton Police Officer [REDACTED] was the first to arrive. Officer [REDACTED] entered the foyer of the YMCA and located Patterson. While Patterson spoke to Officer [REDACTED] another patron entered the YMCA. This patron, Charles Nicholas (Nicholas), overheard the conversation occurring between Patterson and Officer [REDACTED]. Nicholas interjected, stating Zoran just approached him in the parking lot, was acting strangely, and was now walking southbound along the exit driveway of the YMCA.

While Officer [REDACTED] spoke with Patterson and Nicholas, Zoran continued southbound toward and through the intersection of 2nd Street Northwest and West Lake Avenue.

Officer [REDACTED] exited the YMCA, entered his car and began to make his way out of the YMCA parking lot.

After clearing the intersection, Zoran noticed Sean Richards (Richards) and Tessa Jordan (Jordan) as they exited Richards' vehicle which Richards just parked on 2nd Street Northwest. As the couple crossed the street on foot and began to enter The Coffee Pot, a local restaurant, Zoran engaged them in conversation. Zoran's erratic behavior and demeanor at the time of their brief interaction led Richards to believe Zoran may try and break into his car. Richards watched Zoran from the entryway of the restaurant as Zoran briefly loitered near his car before walking back in the direction of the Lake Anna YMCA through a snow-covered parking lot used by Lakeview United Methodist Church. This snow-covered lot was vacant except for a single white pick-up

truck parked near the back of the lot where a trash dumpster was also present. The parking lot was covered by an exterior security camera of the Sitting Pretty Hair and Nail Boutique which operated out of the brick building on the southside of the parking lot.

Zoran was observed on the above described security camera running through the parking lot as Officer [REDACTED] made his way out of the YMCA parking lot and towards Zoran. Zoran appeared to attempt to hide from Officer [REDACTED] behind the hood of the pick-up truck. Officer [REDACTED] observed Zoran, and with his lightbar activated drove across the street and into the parking lot. Zoran walked out from behind the truck and away from Officer [REDACTED]. Officer [REDACTED] exited his patrol vehicle and ordered Zoran to "stop" and "come here." Zoran ignored these commands and walked away from Officer [REDACTED]. Officer [REDACTED] approached Zoran on foot. As Officer [REDACTED] made his way closer to Zoran, Zoran turned around to face him, placed a bag he was carrying on the ground and produced a knife. Officer [REDACTED] continued to give Zoran commands to "stop" and "show me your hands." Zoran replied to Officer [REDACTED] "no, you stop" and Zoran began walking towards Officer [REDACTED]. Officer [REDACTED] then began walking backwards and used his police radio to request his back-up officer expedite his response to the scene. Zoran then walked backwards through the lot from the west to the east, away from Officer [REDACTED] while still facing him. As Zoran walked backwards he changed his grip on the knife so that the blade would face his body (a grip more conducive to stabbing rather than slicing). Officer [REDACTED] with his pistol now in hand and directed at Zoran, continued to give Zoran additional commands to "drop the knife" and variations thereof.

As Zoran walked backwards through the lot away from Officer [REDACTED] Officer [REDACTED] arrived on scene. Officer [REDACTED] arrived from the area of West Lake Avenue and 3rd Street Northwest. Officer [REDACTED] quickly exited his patrol vehicle and began to slowly walk toward Zoran himself. Officer [REDACTED] initially directed his taser at Zoran as he approached. Officer [REDACTED] also gave Zoran multiple commands to "drop it." As the two officers approached, Zoran briefly paused near the truck and took a lowered squatting stance. While squatting, Zoran placed the bookbag he had been holding by a small strap in his hand over his shoulders and onto his back. Zoran then continued backing away from the officers while still facing them and ignoring their commands.

Upon having walked backwards through the majority of the parking lot, Zoran stopped abruptly and charged towards Officer [REDACTED]. Officer [REDACTED] reported attempting to utilize his taser to attempt to stop Zoran but found his taser unresponsive. Officer [REDACTED] reported that he would have shot Zoran but did not due to a concern for where his projectiles could ultimately come to rest noting the open space behind him that was occupied by moving cars and people in the area.

Though Zoran abruptly charged at Officer [REDACTED] Zoran stopped himself within mere feet of making physical contact. Zoran then slowly and deliberately began to walk towards the officers. The two police officers then walked backwards through the lot away from Zoran while they continued to give Zoran further commands that he ignored. As Zoran approached the officers he began giving them commands to "go back to your car(s)."

Zoran continued to advance on the officers. While backing up, Officer [REDACTED] transitioned from holding his malfunctioning taser to his duty pistol. Once past the pick-up truck, Officer [REDACTED] began walking around the hood of the truck in an attempt to create distance and cover from Zoran. As Officer [REDACTED] walked backwards around the hood of the pick-up truck Zoran changed direction and began to advance towards Officer [REDACTED] Officer [REDACTED] who was walking backwards, now near Officer [REDACTED]'s patrol vehicle and the road, then fired a single shot that struck Zoran. Zoran suffered a single penetrating/perforating ballistic gunshot wound that entered his torso, passed through his body, and exited near the right side of his spine.

After being shot, Zoran took one or two more steps forward and fell to the ground. Zoran laid on the ground, appeared to attempt to stand up momentarily before rolling onto his stomach. Officer [REDACTED] approached, then stood over Zoran in a mounted position and attempted to gain control of Zoran's right arm. Zoran remained noncompliant and refused to give Officer [REDACTED] his hand and arm so that he could be handcuffed. In the ensuing moments Zoran lost consciousness, was placed in handcuffs, given first aid and removed from the scene via ambulance. Zoran was taken to a nearby hospital, where he died shortly after arrival.

Crime Scene Processing

The BCI Special Investigations Unit (SIU) and Crime Scene Unit (CSU) responded to the Lake Anna YMCA, 500 West Hopocan Avenue, Barberton, Ohio and a small unmarked gravel parking lot across the street on the southwest corner of West Lake Avenue and 2nd Street Northwest. This gravel parking lot was located behind, and utilized by, the Lakeview United Methodist Church, 211 3rd Street Northwest. This snow-covered gravel parking lot is the location where the shooting occurred.

BCI CSU personnel documented, processed and preserved items of potential evidence. The process included the search for, documentation and collection of potential evidence. Detailed photographs and crime scene reports were completed with the below information only summarizing some of the more significant findings. The scene was further documented with a FARO Focus laser scanner.

Gravel Parking Lot Scene

BCI CSU SA Boerner and SA Hootman processed the scene of the shooting.




Figure 5, showing Zoran's knife pictured with a scale upon collection.

All items of evidence were transported to the BCI Richfield Office (4055 Highlander Parkway, Richfield, Ohio 44286) and placed into temporary evidence locker #10 with the exception of Item 11 (Zoran's clothing which were received from Akron General Hospital). Item #11 was first placed in the drying room. Once dry, the clothing was examined, photographed and placed into evidence bags and moved to evidence storage.

Zachary Zoran Clothing and Personal Affects Examination

On January 3, 2023, BCI agents packaged Zoran's clothing that was previously held in the secure drying room at BCI Richfield. Agents noted significant red and brown staining in the clothing and a defect present in some of the garments indicative of an object penetrating the garments. The locations of these defects in the clothing is consistent with Zoran being shot in the abdomen as noted elsewhere throughout this report.

Summa Health Systems - Akron General Hospital

During the initial BCI response, a BCI agent responded to Summa Health Systems – Akron Campus (Akron General Hospital) and was granted access to the operating room where the agent observed numerous medical personnel providing care to Zoran. At approximately 1148 hours, medical care stopped and Zoran was declared deceased. BCI subsequently received from the hospital staff a large semi-transparent bag containing Zoran's clothing and personal affects contained therein.

According to subsequent examination by medical personnel at the hospital, Zoran's single perforating/penetrating gunshot wound entered through his abdomen and exited his back. No ballistic evidence was recovered at the hospital.

Autopsy

On December 27, 2022, Summit County Medical Examiner Doctor Lisa Kohler conducted a forensic autopsy of Zoran. BCI attended this autopsy and learned Zoran's injuries included the following:

Barberton Police Department

BCI responded to the Barberton Police Department and met with and photographed the two involved officers. They were identified as Officer [REDACTED] who did not fire his weapon, and Officer [REDACTED] who did fire his duty pistol a single time. Both officers declined to give a statement at that time.

BCI photographed both officers, who were dressed in their duty uniforms, as they appeared during the incident. Both officers' uniforms were navy blue in color, had Barberton Police Department patches on the shoulders and silver badges affixed to their chests. Officer [REDACTED] was photographed wearing his Barberton Police Department coat, which he wore during the incident,

that also had Barberton Police Department patches on the shoulders. Both men wore navy blue police style uniform pants, black boots and typical police duty belts on their persons.

BCI collected Officer ██████' taser and noted in the process of collecting the taser it was turned on and then off. While doing so the back display indicating the device was functioning properly failed to turn on.

BCI also collected Officer ██████ pistol, a .45 caliber Smith & Wesson M&P, bearing serial number ██████. A magazine was seated in the pistol at the time of collection and a cartridge was found in the chamber of the gun. The magazine, once removed from the pistol was found to contain 9 cartridges. Officer ██████ stated that he "tops off" his duty pistol, meaning he would carry the pistol with a fully loaded magazine with an additional cartridge in the chamber of the gun, for a total of 11 cartridges. Consequently, the 10 cartridges found in the magazine and chamber of the pistol were indicative of the weapon being fired a single time.

Neighborhood Canvass

While the crime scene was being processed, agents conducted a neighborhood canvass in the area of the shooting incident. The purpose of the canvass was to identify and interview potential witnesses to the officer-involved shooting. The canvass was also conducted to identify any potential sources of video surveillance. Multiple witnesses to the event were located and identified. Information obtained from these witnesses is detailed in the “interviews” section of this report.

Video Surveillance Canvass

While conducting a canvass of the area surrounding the shooting scene, agents located video surveillance cameras on the Lake Anna YMCA building and on the Sitting Pretty Hair & Nail Boutique. Relevant footage of the shooting incident was obtained from both of these locations.

BCI Laboratory Analysis

Various items of potential evidence were submitted to the BCI Laboratory for analysis. The actual reports should be consulted as the following synopsis does not include many of the details from the full reports.

Firearms

Officer [REDACTED] firearm, and the cartridge casing collected from the scene were submitted to the BCI Firearms Section for analysis. Officer [REDACTED] firearm was determined to be operable. Further, by comparing the cartridge casing collected from the scene to known standards from the weapon, identification was made confirming Officer [REDACTED] weapon did fire the cartridge casing found at the scene.

Taser

Officer [REDACTED] taser was collected and submitted to the BCI Cyber Crimes Unit (CCU). BCI Special Agent Supervisor (SAS) Justin Root (Root) authored the Investigative Report detailing the findings of that analysis. SAS Root was unable to conduct a spark test of the taser because it would not turn on. The taser appeared to have not been downloaded since it was put into service on 2/6/2013. Accurate records of date and time activity for the taser could not be retrieved due to the age and condition of the device. The Investigative Report authored by SAS Root should be referred to for a full understanding of the findings of that analysis.

Cellular Telephone

On January 9, 2023, BCI obtained a search warrant through the Summit County Common Pleas Court to search Zoran's phone which was recovered from the scene.

Witnesses

BCI conducted audio recorded interviews of multiple witnesses throughout the investigation. All the interviews were conducted in person unless otherwise noted.

Margaret Patterson

While walking to work, Patterson noticed Zoran across the street from her “yelling and screaming at cars going by, talking to himself maybe, I’m not entirely sure.” Patterson walked into the parking lot across from the YMCA to avoid Zoran.

Zoran then began to yell at Patterson “Hey Lady! Hey Lady!” Patterson did not turn around to face Zoran. Rather, she continued walking in the direction of the YMCA. Zoran continued to approach Patterson and as he got closer said “give me your car keys.” Patterson told Zoran she didn’t have a car or car keys. Zoran insisted Patterson give him her keys. Zoran told Patterson she “needed to empty my pockets and that I needed to empty my bookbag and give him everything I had on me.” Patterson told Zoran she would not give him her belongings and told Zoran to leave her alone. Zoran told Patterson “I’m not going to leave you alone.” Patterson began to speed up, walking as fast as she safely could in the snow. Patterson did not stop or turn around at any point, stating she “was just afraid that if he grabbed me I wouldn’t have any way to defend myself so I just kept running.” Patterson then began “screaming for somebody to call 911.” Eventually Patterson “saw a woman crossing the street” and told this woman “Please call the cops! Please call the cops!” Patterson herself began calling 911 at the same time. Zoran was still behind Patterson and giving her orders to “give me your stuff, give me your bag.”

Once Patterson and Zoran reached the main doors of the YMCA, Zoran stopped outside as the women entered the facility and Zoran “kinda stared me down through the door.” Patterson reported “an elderly couple pulled up and he just started screaming at their car and screaming at them.” Patterson then remained in the foyer of the YMCA.

Moments later, Patterson observed Zoran and Barberton Police Officers [REDACTED] and [REDACTED] from her vantage point in the foyer of the YMCA. Patterson recalled that moments later she watched as one of the officers drew a weapon, which she could not identify, as Zoran approached them. Patterson believed one of the officers had to walk back, retreating behind a car. Patterson did not see the shooting but heard “what sounded like something” but was not positive about the origin of the sound she heard.

Law Enforcement Witness

The following paragraphs are an abbreviated versions of Officer [REDACTED]'s account of his actions and perceptions of this incident. A more detailed account of Officer [REDACTED]'s interview may be obtained from reviewing the video recording of his interview.

Barberton Police Officer [REDACTED]

Officer [REDACTED] reported he was dispatched to call of a male trying to take a female's keys. The dispatch didn't seem right to him, so he used his emergency lights and siren intermittently while responding.

When Officer [REDACTED] arrived at the YMCA, he pulled in the parking lot from Hopocan Avenue and parked near the front entrance. A male was outside salting the sidewalk; and as Officer [REDACTED] exited his cruiser, the male pointed to the front door of the YMCA.

As Officer [REDACTED] entered the YMCA, he observed a female inside the front entrance. The female was visibly upset, shaking and crying. She provided a brief explanation of what happened. When Officer [REDACTED] asked what the male looked like, she pointed to the area of 2nd Street NW and W. Lake Avenue and said, "There he is," (5 minutes 15 seconds). Officer [REDACTED] asked the female to stay at the YMCA because he needed more information but told her he wanted to go speak with the male.

As Officer [REDACTED] drove out of the YMCA parking lot, he could see the male "kind of like jogging" west through a parking lot. The lot was located on the southwest corner of 2nd Street NW and W. Lake Avenue. There were no vehicles in the lot besides a white pick-up truck. While Officer [REDACTED] drove toward the subject, the subject squatted down in front of the white truck and was looking around as if he was hiding. Officer [REDACTED] did not believe the subject could see him and found the subject's behavior confusing.

The subject then got up and began walking away. At that time, Officer [REDACTED] exited his cruiser and told the subject, "Hey come here. You're not in trouble. I just need to talk to you." The subject started jogging away from him and Officer [REDACTED] followed. Officer [REDACTED] told the subject to stop again and the subject continued jogging quicker. Officer [REDACTED] radioed that the subject was starting to run from him. When the subject reached the alley, Officer [REDACTED] was behind the subject, facing the subject's back. Officer [REDACTED] said, a third time, "Stop! I need to talk to you." The subject turned around, and as he did so, Officer [REDACTED] could see the blade of a knife in the subject's right hand. Officer [REDACTED] explained it freaked him out. He took a step back away from

the subject, drew his firearm and said, "Drop the knife." Officer [REDACTED] then radioed the subject had a knife.

The subject made his way east through the parking lot, while Officer [REDACTED] continued ordering the subject to drop the knife. Officer [REDACTED] told the subject he did not want to shoot him and gave him more stern commands to drop the knife. Officer [REDACTED] arrived while they moved east through the parking lot. He was on Officer [REDACTED]'s left side and parallel to him. The subject then started lunging toward them and then backing up. After doing that a few times, it got to the point where it was getting aggressive. As the subject started moving directly toward them, Officer [REDACTED] took cover behind the white truck.

Officer [REDACTED] remembered there were people in the background which were in his line of fire and because of that, he did not have a clear shot. Then the subject started charging toward Officer [REDACTED]. As Officer [REDACTED] was squeezing his trigger, he heard "boom" and immediately thought they had just shot the guy.

Officer [REDACTED] explained Officer [REDACTED] originally had his taser out and he did not know Officer [REDACTED] had transitioned to his firearm. After the subject was shot, the subject stood there frozen and dazed. After approximately a minute, the subject collapsed to the ground and was still clinching the knife. Officer [REDACTED] gave additional commands for the subject to drop the knife. Eventually, the subject opened his hand and Officer [REDACTED] walked up to the subject and kicked the knife away. The subject was still actively showing aggression, so Officer [REDACTED] got on top of the subject and pinned his arms down with his knees. The subject continued to actively resist, so they handcuffed him.

They cut the subject's backpack off and some of his clothing and located a wound on his stomach and on his back. The fire department then arrived and transported the subject from the scene.

During the incident, it was sunny outside but the parking lot was snow covered. When the subject was lunging toward them, he was within 10 to 12 feet of the officers. Officer [REDACTED] said he was fearful when the subject was coming at him with the knife in his hand. Officer [REDACTED] explained he had been on hundreds of calls where a subject had a knife; and when an officer displayed his firearm, the subject complied and dropped the knife. When this subject did not drop the knife, Officer [REDACTED] thought he was going to get stabbed, and it was going to end badly for him or Officer [REDACTED]. Officer [REDACTED] reiterated the only reason he had not discharged his firearm was because of the people in the background.

Officer [REDACTED] believed his actions were consistent with his training. He had spoken with the command staff of his department after the incident but no one had asked him to lie or tried to influence his statement.

Officer [REDACTED] had not watched any video footage of the incident before being interviewed. Prior to the conclusion of the interview, Officer [REDACTED] was offered to review his body-worn camera video footage. He and his attorney reviewed the video and afterward indicated they did not wish to add any additional information to Officer [REDACTED] s statement.

Involved Law Enforcement Officer

BCI conducted a video recorded interview with the involved officer, [REDACTED] and reviewed his personnel files and training records. Included within this section are abbreviated versions of the Officer [REDACTED] account of his actions pertaining to this incident and/or discharging his weapon. A more detailed account of this information may be obtained by reviewing the video recorded interview.

Officer [REDACTED]

Officer [REDACTED] stated he and Officer [REDACTED] “got a call of a suspicious person that confronted a woman in the parking lot of the YMCA.” Officer [REDACTED] stated he arrived from the direction of West Lake Avenue and 3rd Street NW.

Officer [REDACTED] upon exiting his patrol vehicle, observed Zoran and Officer [REDACTED] standing near a trash dumpster along the northwest corner of the building (identified by investigators as the Sitting Pretty Hair & Nail Beauty Boutique, 208 2nd Street Northwest, Barberton, Ohio). As Officer [REDACTED] exited his patrol vehicle, he heard Officer [REDACTED] tell Zoran “drop the knife.”

As Officer [REDACTED] exited his vehicle, Zoran began walking eastbound through the parking lot. Officer [REDACTED] stated, “Patrolmen [REDACTED] said ‘Put it down’, I believe I said a couple times maybe, ‘Put the weapon down as well.’” Officer [REDACTED] then described taking his taser out near where he entered the parking lot, noting Officer [REDACTED] had his service weapon out at the time.

Zoran, upon reaching the end of the parking lot, reversed course and began to walk towards the officers. Officer [REDACTED] stated “I attempted to discharge my taser. My taser, I tried twice, my taser, it was malfunctioning.” Officer [REDACTED] then put his taser in his left side pant pocket and

“pulled out my service revolver.” Note: Officer ██████ misspoke while referring to his Smith and Wesson M&P pistol as a revolver.

Officer ██████ stated he and Officer ██████ gave Zoran “several more commands ‘drop the knife’” as they walked in the parking lot. Officer ██████ demonstrated for investigators with his right hand and arm out in front of him Zoran’s actions. Officer ██████ stated “He came towards me with the knife in his right hand and I fired one time.”

Officer ██████ stated he observed Zoran as “he proceeded to drop.” Officer ██████ provided cover as Officer ██████ attempted to handcuff Zoran. Sergeant Donley then arrived and began to assist the officers.

Officer ██████ stated “We kicked the knife,” and pointed to the area on the screen where the knife was kicked. Officer ██████ stated “Then we attempted to find where the wound was.” Officer ██████ touched his left abdomen in an effort to show investigators where the entry wound on Zoran was located, as he described looking for the wound. Officer ██████ continued that he believed “it exited out his right kidney area, somewhere around there.”

Officer ██████ stated officers then handcuffed Zoran and cut off his bookbag as paramedics arrived.

When asked, Officer ██████ stated the weather at the time was cold and the ground was snow and ice covered. However, he did not believe these conditions had any impact on his or Zoran’s movements through the parking lot.

When asked, Officer ██████ stated that at the time he fired his weapon, he believed he was “between 10 and 15 feet” from Zoran who was facing him and “looking right at me.”

When asked, Officer ██████ stated he became aware that Zoran had a knife in his possession and “definitely saw the knife, um, when we were about in the middle of the parking lot.”

When asked, Officer ██████ estimated the time from when he first noticed the knife to having fired his weapon to be between one minute and one and a half minutes.

When asked, Officer ██████ recalled Zoran saying to him and Officer ██████ “to get back into our cruisers and leave.”

When asked if he recalled the commands he gave to Zoran, Officer ██████ stated he told Zoran “drop the knife, get on your knees.” Officer ██████ then stated that Officer ██████ primarily gave Zoran commands, and he provided limited verbal commands because he has found through his experience when multiple officers provide commands, it becomes more distracting than helpful.

When asked if he perceived any other options than the use of deadly force at the time he fired his weapon, Officer ██████ stated “There were no other option in my mind.”

When asked what he thought would have likely happened had he not used deadly force, Officer ██████ stated “Um, that I would have been stabbed.”

When asked, Officer ██████ stated he did fear for his safety and the safety of Officer ██████. Officer ██████ felt his actions and the actions of Officer ██████ were consistent with his training.

When asked about specific training pertaining to persons with edged weapons, Officer ██████ stated he was aware that a person armed with a knife “within, can’t remember exactly, but, it, you know, they can cover a great deal of distance in a short span with, and he, like I said he was within 10 to 15 feet of me when this happened.”

Officer ██████ stated he had not watched his body-worn camera video recording of the incident prior to the interview. When given the opportunity to do so at the end of the interview, Officer ██████ declined.

BCI special agents were unable to interview Zachary Zoran as he succumbed to his wounds before agents could attempt to conduct an interview with him.

Zachary Zoran Medical Records

BCI executed three warrants relevant to the past medical history and treatment of Zoran as part of this investigation. Pertinent information obtained from each medical/treatment record is more fully described below. A more complete accounting of these records may be obtained by reviewing the actual records themselves.

BCI obtained records of treatment Zachary Zoran received from The Light Center Recovery pursuant to a search warrant served on the organization.

Suma Hospital

BCI obtained records of treatment Zachary Zoran received from Suma Hospitals pursuant to a search warrant. Those records documented attempted lifesaving action and treatment Zoran received at the hospital after being shot by Officer [REDACTED]. These records also detail the death of Zoran, which occurred shortly after his arrival to the hospital.

Summit County Medical Examiner

BCI obtained the Forensic Toxicology Laboratory Report, Report of Autopsy, and Report of Investigation from the Summit County Medical Examiner's Office on March 15, 2023. The "Cause of Death" for Zachary Zoran was listed as "Gunshot wound to the torso." The "Manner of Death" was listed as "Homicide: Shot by police." The injuries described within the report appeared consistent with injuries sustained from a gunshot to the abdomen. No suspicious injuries to other parts of the body were identified. The toxicology screening noted Zoran's blood tested positive for methamphetamine at the time of his death.

Zachary Zoran – Background, Computerized Criminal History

Background information for Zoran was compiled and reviewed. It included researching past police reports involving Zoran, criminal history records, court records, open/closed source database inquires and social media posts.

Zoran sent messages similar to those described and documented above to other individuals through Facebook in the days preceding his death. The reader of this report is encouraged to review the full collection of Facebook records for a fuller understanding of Zoran's activity while using Facebook.

Prior Police Encounters

A records inquiry completed by Barberton Police revealed the department had no encounters with Zoran prior to the officer-involved shooting. However, Zoran has had multiple police encounters with other area police departments leading up to his death. Documented police interactions between Zoran and the Cuyahoga Falls Police Department and the Akron Police Department in particular are more fully described below. Note that Cuyahoga Falls Police Department obtained a warrant to arrest Zoran for aggravated menacing for threats Zoran made to his mother the day before his death. Akron Police also interacted with Zoran in two meaningful encounters two days before his death. These interactions, including the review of Akron Police body-worn camera recordings, are documented below.

Zoran, who had called 911 during the early morning hours of December 24, 2022 to report what he thought was suspicious behavior, was confrontational with police and hesitant to put down a baseball bat during the interaction.

Later that morning, Akron Police were again dispatched to the home because a group home supervisor reported Zoran had microwaved an iPad and was acting aggressive towards his housemates. Akron Police again found Zoran in possession of a baseball bat. Eventually Akron Police were able to remove the bat (and a knife) from Zoran. Akron Police then transported Zoran to the hospital for a psychiatric evaluation.






Figure 14, Frame 001441 of Officer ██████'s body camera.




Figure 16, Frame 005526 of the Sitting Pretty Hair & Nail Boutique Exterior Side Camera.




Figure 18, Frame 002290 of Officer [REDACTED] body camera.




Figure 20, Frame 005760 of the Sitting Pretty Hair and Nail Boutique surveillance camera alongside frame 007840 of Officer ██████ body camera and frame 003305 of Officer ██████'s body camera synced.

This image showed Zoran on the ground and Officer [REDACTED] standing over him. Note Zoran's knife visible in the red oval. After being shot and falling to the ground, Zoran continued to ignore commands and ultimately appeared to lose consciousness while being placed into handcuffs.

Approximately 1 minute and 21 seconds transpired from the time Officer [REDACTED] stepped out of his patrol vehicle to the time Zoran was shot. During that time Officer [REDACTED] gave Zoran over 25 total commands which included ordering Zoran to "drop the knife" or a command very similar thereto 18 times. Zoran ignored all of those commands. Likewise, Officer [REDACTED] ordered Zoran to "drop it" 10 times. Officer [REDACTED] commands were also ignored by Zoran.

After having initially walked away from the two officers, Zoran reversed course and took approximately 38 steps towards the officers prior to being shot.

Conclusion

Based upon the tangible/physical evidence, video and audio recordings, statements from uninvolved law enforcement officers, statements from witnesses, and the totality of the investigation, it is concluded that Barberton Police Officers [REDACTED] and [REDACTED] were dispatched to investigate a possible attempted robbery which occurred outside the Lake Anna YMCA, 500 West Hopocan Avenue, Barberton, Ohio. Officer [REDACTED] was first to arrive and located the victim of this offense inside the foyer of the YMCA. Officer [REDACTED] quickly learned the suspect of this offense was still in the area, walking just outside the YMCA. Officer [REDACTED] returned to his car, exited the YMCA parking lot, crossed the street, and encountered the subject, Zachary Zoran, in a snow-covered gravel parking lot.

Zoran, who appeared to have been attempting to hide from Officer [REDACTED] walked out from behind a truck and away from Officer [REDACTED]. Officer [REDACTED] exited his patrol vehicle and ordered Zoran to “stop” and “come here.” Zoran ignored these commands and walked away from Officer [REDACTED]. Officer [REDACTED] approached Zoran on foot. As Officer [REDACTED] made his way closer to Zoran, Zoran turned around to face him, placed a bag he was carrying on the ground and produced a knife. Officer [REDACTED] continued to give Zoran commands to “stop” and “show me your hands.” Zoran replied to Officer [REDACTED] “no, you stop” and began walking towards him. Officer [REDACTED] then began walking backwards and used his police radio to request Officer [REDACTED] expedite his response to the scene. Zoran then walked backwards through the lot from the west to the east, away from Officer [REDACTED] while still facing him. As Zoran walked backwards he changed his grip on the knife so that the blade would face his body (a grip more conducive to stabbing rather than slicing). Officer [REDACTED] with his pistol now in hand and directed at Zoran, continued to give Zoran additional commands to “drop the knife” and variations thereof.

As Zoran walked backwards through the lot away from Officer [REDACTED] Officer [REDACTED] arrived on scene. Officer [REDACTED] arrived from the area of West Lake Avenue and 3rd Street Northwest. Officer [REDACTED] quickly exited his patrol vehicle and began to slowly walk toward Zoran himself. Officer [REDACTED] initially directed his taser at Zoran as he approached. Officer [REDACTED] also gave Zoran multiple commands to “drop it.” As the two officers approached, Zoran briefly paused near the truck and took a lowered squatting stance. While squatting, Zoran took the bookbag he had been carrying with a single hand holding a shoulder strap and placed the bookbag over his shoulders and onto his back. Zoran then continued backing away from the officers while still facing them and ignoring their commands.

Upon having walked backwards through the majority of the parking lot, Zoran stopped abruptly and charged towards Officer [REDACTED]. Officer [REDACTED] reported trying to utilize his taser to attempt to stop Zoran but found his taser unresponsive. Officer [REDACTED] reported that he would have

shot Zoran but did not due to a concern for where his projectiles could ultimately end up noting the open space behind him that was occupied by moving cars and people in the area.

Though Zoran abruptly charged at Officer [REDACTED] Zoran stopped himself within mere feet of making physical contact. Zoran then slowly and deliberately began to walk towards the officers. The two police officers then walked backwards through the lot away from Zoran while they continued to give Zoran further commands that he ignored. As Zoran approached the officers, he began giving them commands to "go back to your car(s)."

Zoran continued to advance on the officers. While backing up, Officer [REDACTED] transitioned from holding his malfunctioning taser to his duty pistol. Once past the pick-up truck, Officer [REDACTED] began walking around the hood of the truck in an apparent attempt to create distance and cover from Zoran who focused his attention on him. As Officer [REDACTED] walked backwards around the hood of the pick-up truck Zoran changed direction and began to advance towards Officer [REDACTED] Officer [REDACTED] who was walking backwards, now near Officer [REDACTED]'s patrol vehicle and the road, then fired a single shot that struck Zoran. Zoran suffered a single penetrating/perforating ballistic gunshot wound that entered his torso, passed through his body, and exited near the right side of his spine.

Approximately 1 minute and 21 seconds transpired from the time Officer [REDACTED] stepped out of his patrol vehicle to the time Zoran was shot. During that time Officer [REDACTED] gave Zoran over 25 total commands which included ordering Zoran to "drop the knife" or a command very similar thereto 18 times. Zoran ignored all of those commands. Likewise, Officer [REDACTED] ordered Zoran to "drop it" 10 times. Officer [REDACTED] commands were also ignored by Zoran.

After having initially walked away from the two officers, Zoran took a total of approximately 38 combined walking or running steps towards the two officers prior to being shot.

After having been shot, Zoran took one or two more steps forward and fell to the ground. Zoran laid on the ground and appeared to attempt to stand up momentarily before rolling onto his stomach. Officer [REDACTED] approached, stood over Zoran in a mounted position and attempted to gain control of Zoran's right arm. Zoran remained noncompliant and refused to give Officer [REDACTED] his hand and arm so that he could be handcuffed. In the ensuing moments Zoran lost consciousness, was placed in handcuffs, given first aid, and removed from the scene via ambulance. Zoran was taken to a nearby hospital, where he died shortly after arrival.

This conclusion was based on the totality of the investigation. Throughout the investigative process, investigators continually evaluated the physical evidence, in conjunction with audio and video recordings, forensic findings, witness statements, involved officer statements and other
