NARRATIVE

**SHOOTING INTO HABITATION / NAMED SUSPECT
2024-16108**

On Wednesday, January 17th, 2024, while assigned to 4A38, P.O. Reynolds #1236 and I received a radio broadcast to respond to 7702 Canton avenue for a code one shot spotter alert. This is in connection with RMS (2024-015839). We were assisted by members of 4A31 P.O. Ayers #635 & P.O. Lyberger #1547, members of 4A32 P.O. Kane #997 & P.O. McCartney #820, members of 4A35, P.O. Blocton #32 & P.O. Morrison #1017, member of 4S33, Sgt. Wills #9321. We were also assisted from members of the 2nd, 3rd and 5th district, along with various support units. Below are the details of the incident.

After the initial incident of RMS (2024-015839), we began to tour the area to ensure no persons or property had been harmed or damaged. P.O. Reynolds knocked on the home of 7629 Spafford avenue, and was met by [REDACTED] (victim). [REDACTED] said that she was sitting on her living room couch, when she initially heard the shots being fired. [REDACTED] then ran up stairs to check on her son to ensure he was ok. [REDACTED] then heard more shots striking her home. P.O. Reynolds observed one bullet hole in the front door of the home and two additional bullet holes in the livingroom wall. [REDACTED] or her son did not require EMS. P.O. Reynolds provided her with a copy of the RMS number and SIU was requested on scene.
