#### Narrative:

On Monday, March 10, 2025, at 1220hrs, SA Boerner was contacted by SA Jon Leiber and was requested to further document Jazmir Tucker's jacket (Matrix Item #21). SA Leiber requested additional photographs of the zippers of the jacket, length of the zippers and direction in which the zippers would need to be pulled to open/close.

On Monday, March 17, 2025, at 1628hrs, SA Boerner sent an email to AP Betsy Turney requesting to examine Tucker's jacket on Tuesday, March 18, 2025.

On Tuesday, March 18, 2025, at approximately 1040hrs, SA Boerner received Tucker's jacket from AP Turney (Figures 1-, Overall photographs). SA Boerner subsequently photographed and examined Tucker's jacket. There were two zippers located on the front of the jacket. One on the left side of the jacket and one on the right side of the jacket. Both zippers measured approximately 11 inches in length. To close the pockets, the zippers would need to be pulled towards the neck of the jacket and to open the pockets, the zippers would need to be pulled down towards the waist of the jacket.
