#### Narrative:

On May 20, 2022, the Ohio Bureau of Criminal Investigation (BCI) was requested by the Miami Township Police Department (MTPD) in Clermont County to assist with an Officer-Involved Critical Incident (OICI) that occurred at 947 State Route 28 Business, Milford, Ohio between the Miami Township police officers and Camille Weems (Weems).

Officer Ann Morgan (Ofc. Morgan) was identified as being a police officer who witnessed and/or had some level of involvement in the May 20, 2022, Officer-Involved Critical Incident, which occurred in the area of 947 State Route 28 Business, Milford, Ohio. Reportedly, Ofc. Morgan did not discharge a firearm during the course of the incident. The purpose of the interview was to obtain all relevant information of the incident known or observed by this officer.

On May 26, 2022 at approximately 1316 hours, Ofc. Morgan agreed to meet Ohio BCI agents for a voluntary interview and present for Ofc. Morgan in the interview was Fraternal Order of Police (FOP) Ohio Labor Council Staff Representative Barry Gray and FOP Lawyer Stew Matthews, and conducting the interview was Ohio Bureau of Criminal Investigation Special Agents Steven Seitzman (SA Seitzman) and Douglas Eveslage (SA Eveslage). During the incident, Ofc. Morgan wore her standard police uniform, ballistic vest, and police issued equipment. She drove a MTPD marked vehicle with MTPD emblems and emergency lights. She considered herself to be well–represented as a police officer during the incident.

Ofc. Morgan explains that she was dispatched on a "check the well fare" of Camille Weems, with other officers including Crisis Intervention Trained (CIT) civilian Matt Hale, 947 State Route 28 Business about thirty minutes prior to responding back to the address when the OICI occurred. Ofc. Morgan stated that the well fare check also advised responding officers that Weems possessed a firearm. Ofc. Morgan stated that Weems did not want any police assistance and Weems stated she was not suicidal or in need of medical attention, so Matt Hale placed a

business card under Weems' apartment door and everyone left (See attachment #01 for further details about prior contact with Weems).

Ofc. Morgan stated that the next dispatch to 947 State Route 28 Business advised a topless female was in the apartment complex parking lot with a firearm and she discharged the firearm in the air. As Ofc. Morgan arrived, she heard Officer yelling, "Drop the gun! Drop the gun!" "I'm pretty certain before I had it in park I heard a round go off," explains Ofc. Morgan." Ofc. Morgan stated that she forgot her "AR" (duty rifle) and hesitated to go back for it and "I think I heard another round go off." Ofc. Morgan said that she could not see Weems at this point, but the last time Ofc. Morgan saw her, Weems was walking towards the police vehicles. Ofc. Morgan explained that she ran to the rear of her cruiser but knew she was in a bad location because there were officers in front of her and that she needed to get "on line" if she was going to be able to take a shot. Ofc. Morgan said that she heard one more shot that she believed came from Weems' firearm and then she "heard the numerous AR rounds going off. That's when I knew shit was going bad, cause our guys were shooting, and I fuck it I'm in it with my handgun."

Ofc. Morgan said she moved into position behind a police vehicle and that is when she saw that Weems was "down." Ofc. Morgan noticed "the gun just a few inches from her hand" on the ground and "we are all yelling at her, don't move, don't get the gun, roll over, you know giving commands." Ofc. Morgan stated they all moved forward to administer first aid on Weems.

SA Seitzman asked Ofc. Morgan how much time had lapsed between Weems' last shot and an officer shooting, and Ofc. Morgan said it was "instantaneous." SA Seitzman provided Ofc. Morgan a satellite image of 947 State Route 28 Business and had Ofc. Morgan mark locations of police vehicles and Camille Weems (See attachment # 02).

This interview was concluded at approximately 1335 hours. This interview was audio recorded. See attached audio recording for further details.

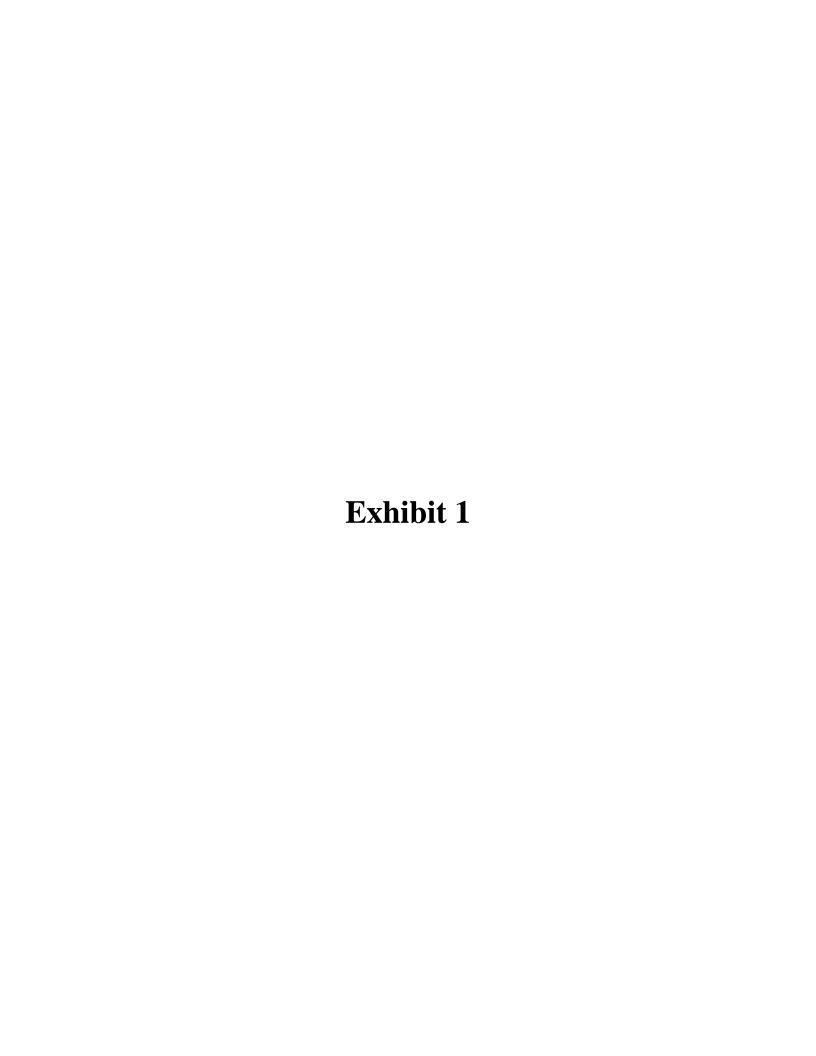

#### Hello Matt,

I had an encounter with Camille Weems tonight. I was not familiar with her before my detail, but due to the odd nature of the call I looked up priors with her. It appears she is quickly becoming a frequent flyer for us. Not certain what/if anything can be done at this point, but thought perhaps you may know if she has a caseworker or had any thoughts. Below is my synopsis for tonight, but we have now been out with her 5 times in 3 weeks (4/25, 4/27, 4/30, 5/1, and now 5/17). It is my understanding that she moved here in February so perhaps she was stable for the first couple months and is off meds or something now. I just wanted to put her on CIT radar in case she wasn't already.

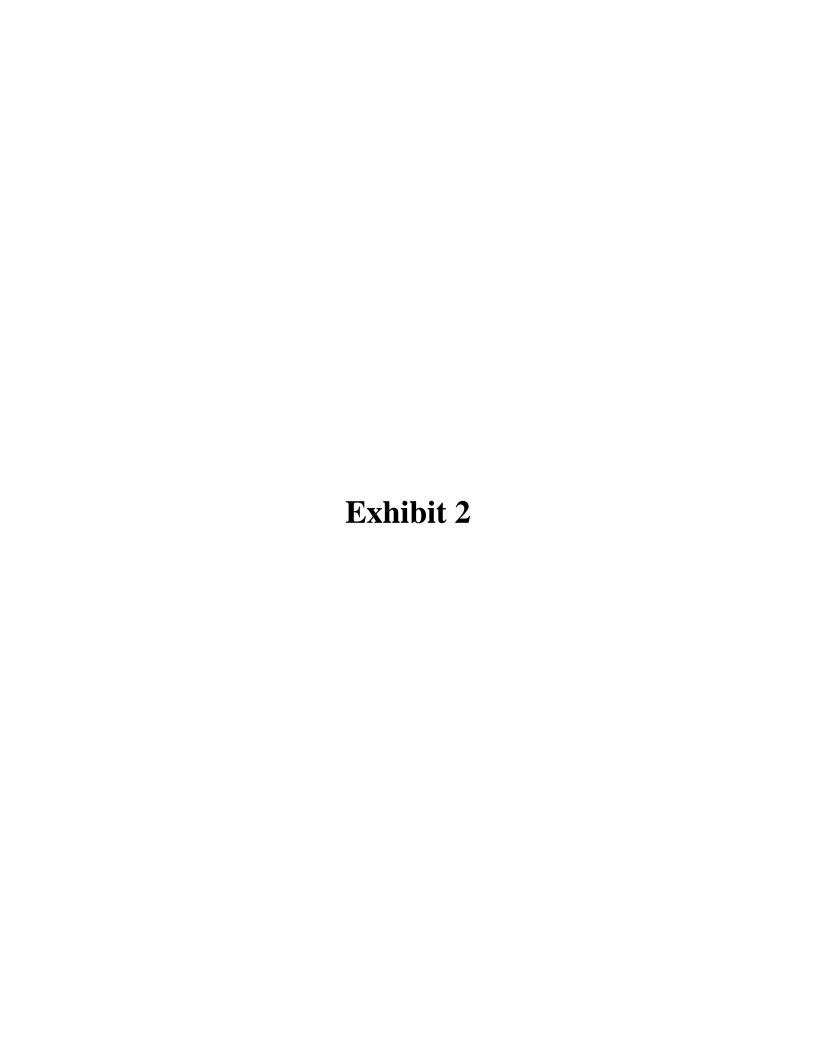


Camille Weems called dispatch for a harassment report. Upon my arrival, Camille asked where she could go to be safe. I asked her what the problem was. She stated that she was being threatened with bodily harm but would not expand on the threats or who was making them. I suggested a hotel. She then stated that "they" would see her leave and might follow her. She asked if I could take her to a hotel. I told her I could as long as it was within Miami Twp. I asked her if she wanted me to call the person and tell them not to have any further contact, but she declined.

She then asked if I could take her somewhere. I advised her I was happy to take her to a friend or someone's house as long as it was in Miami Twp. She asked if I could call her a cab. I provided her with the numbers to Sully's and Dano's. She called one of them and told them that she needed to go to Kenwood and asked how much it would cost. They told her they weren't sure, but could check once they got to her address. After she hung up, she asked if I could follow her to an ATM so she could get money for the cab. I followed her to Ameristop where she went inside. When she came back out, she advised that she couldn't access her money because someone had hacked her account and asked

that I follow her back to her apartment. Once we returned to Berry Lane, I advised her I would enter an EPR which she was appreciative of. I advised her to call 911 if she had any suspicious activity.

After leaving the complex, I looked up priors due to the odd nature of this call. There is an apparent psych history / issue with her which is likely the cause for the report tonight.
