**Narrative:**

On Wednesday, March 26, 2025, at 1308 hours, Ohio Bureau of Criminal Investigation (BCI) Administrative Professional Betsy Turney sent a complete copy of this case file to the Mahoning County Prosecutor's Office (MCPO) via Matrix Exchange. Special Agent Jon Lieber was previously informed by Assistant Section Chief Christopher Kinsler of the Ohio Attorney General's Office Special Prosecutions Section that Mahoning County Prosecutor's Office was appointed as a Special Prosecutor to review this case.
