Narrative:

On April 1, 2022, Ohio Bureau of Criminal Investigation Special Agent Al Bansky received a written statement from Youngstown City Police Officer (Ofc.) Case Lemke (Lemke). Ofc. Lemke was identified as one of the officers who arrived after the officer-involved critical incident. Ofc. Lemke didn't witness the shooting incident.

According to Ofc. Lemke, while on patrol, he received information that Struthers Police Department was in pursuit of a vehicle, heading to the city of Youngstown. Ofc. Lemke was advised by his command not to become involved until they receive more information regarding the pursuit. Minutes later, Ofc. Lemke heard over the police radio that shots have been fired in the area of Steel Street. Ofc. Lemke arrived minutes later at the intersection of Salt Springs Road and Steel Street.

As Ofc. Lemke exited his vehicle, he observed "3 or 4 other officers with their handguns drawn"; giving commands. Ofc. Lemke observed an officer walking backwards, toward him, and stated he was not sure he had been shot. Ofc. Lemke then radioed dispatch that one suspect had been shot and requested an ambulance on the scene and then was advised by his command to back off the scene.
